This memo is to provide notice that the Hospital Transitions program provided by Compass Health and funded by North Sound Behavioral Health Organization will be ending January 31, 2019. We have valued the opportunity to provide support to individuals transitioning from an inpatient psychiatric stay back to their communities and will continue to support these individuals in their transitions through our other programs.

As this program has always been a short-term support, generally 30 days, Compass Health will not be taking new referrals in this program after 1/1/19. We will continue to serve individuals in the program prior to 1/1/19 to support their connections with supports and resources.
