# 7. Report from the Advisory Board - James Mead, Chair

James Mead reported:

- The Advisory Board met on January 9th
- Received report from the Executive Director on the PACT program
- NSMHA is still searching for facility for the Children's E&T
- Motion passed to approve all expenditures before the Board of Directors today
- The Advisory Board is going to purchase a DVD on suicide for educational purposes
- Marie Jubie discussed the legislative dinner/legislative forum and Advisory Board members will have a bus to take them to Olympia for legislative session
- Jail Services contracts amendments were recommended for approval to the Board of Directors
- County Advisory Boards reports received
- Advisory Board members are going to their County Advisory Boards to recommend appointing members to the NSMHA Advisory Board
- Advisory Board thanked Jim King for chairing the Contracting and Funding subcommittee
- Thanked Charles Albertson for his service as Chair of the Advisory Board

# 8. Report from the Executive/Personnel Committee – Mike Shelton, Chair

Mike Shelton stated the Executive Personnel Committee met today but had nothing to report.

# 9. Report from the Quality Management Oversight Committee – Gary Williams, Chair None: OMOC did not meet last month

# 10. Report from the Planning Committee - Janelle Sgrignoli, Chair

Janelle Sgrignoli reported:

- The Planning Committee met last Friday and discussed the Children's E&T issue, plan on working on Children's Services issues this year.
- Discussed the increasing census at Western State Hospital and data analysis will by done by a workgroup consisting of Greg Long, Nancy Jones and Gary Williams was formed to work on this.
- Discussed the PACT proposals received and heard the recommendations from the PACT Evaluation Team to award the PACT Program to Snohomish County. Ms. Sgrignoli made a motion (**#07-002**) to approve the Planning Committee's recommendation for the Program for Assertive Community Treatment (PACT) award to the Snohomish County Consortium of Compass Health, bridgeways and Sunrise Services. NSMHA will develop a contract in collaboration with the provider for start up costs and an ongoing annual award. The contract will be with the lead agency, Compass Health. Seconded by Mr. Shelton, and opened for discussion. Ms. Sgrignoli said had there been enough funds both programs would have been funded and NSMHA will advocate for more funding for PACT. Chair Gossett called for the vote, all in favor, **motion carried (07-002)**.

Ms. Sgrignoli was thanked for her report.

# 11. Report from the Executive Director - Chuck Benjamin, Executive Director

Chuck Benjamin reported:

- Thanked the Planning Committee for their hard work on the contracting and funding workgroups. Regarding PACT, also thanked Skagit County Human Services, 1 WSH liaison, representative from the Department of Vocational Rehabilitation, 2 consumers, 3 advocates and 2 non-voting county coordinators; they did a great job.
- Releasing RFP on February 2 and respondents will have 6 weeks to respond.
- Lacking regional advisory board members, 3 vacancies in Island, 1 in San Juan, 1 Snohomish, 1 in Whatcom, noting the need to get those vacancies filled so the NSMHA Advisory Board can continue their good work.
- EQRO here on January 18<sup>th</sup> and then to the provider agencies. Staff worked hard on this.
- Integrated Crisis Response Secure Detox Pilot going well. NSMHA had joint meeting with Pierce County and discovered that Pierce County is doing their pilot much differently than we are doing ours. Pierce is allowing voluntary admissions and by doing so they are averting court costs.
- Friday, January 12, Senator Hargrove's committee will receive a 20 minute presentation from each pilot on statistics, how many served, etc. It is believed this is to promote continuing the pilots.
- NAMI day is January 15<sup>th</sup> and many Advisory Board members, consumers and advocates will be participating in Olympia. NSMHA is providing the transportation.
- January 16<sup>th</sup> there is a Mental Health Transformation Initiatives meeting in Olympia and the North Sound has people are attending that as well.

Mr. Benjamin was thanked for his report.

# 12. Report from the Finance Officer - Bill Whitlock, Fiscal Officer

Bill Whitlock reported:

- We are not presenting December financial statements because we are waiting for the December accruals.
- The State has deducted \$3,354,707.41 during the life of the WMIP (Washington Medicaid Integration Partnership) project. The funds were deducted from October 2005 to December 2006. Committee discussion followed on WMIP and Janelle Sgrignoli updated the Board on how this is going in Snohomish County. Chair Gossett asked Janelle Sgrignoli to have a one page document prepared for Snohomish County Council members to use while in Olympia. Mike Shelton asked that the whole board receive the document and Ms. Sgrignoli agreed to do so.
- The North Sound Mental Health Administration is proposing changes to the Capital Reserve Policy to bring it inline with Federal and State guidelines. According to Medicaid policy we can not use Medicaid funds for Capital funding purposes.
- We are also asking to change the maximum meal reimbursement rates for the RSN. This will be coming from the Finance Committee.
- We passed the MHD fiscal review relating to the Federal Block Grants contract period October 1, 2004 to September 30, 2006.

Mr. Whitlock was thanked for his report.

# 13. Report from the Finance Committee – Kirke Sievers, Chair

Kirke Sievers reported:

• The Finance Committee met today and reviewed all payables, time cards, and expenses stating he has two motions to bring forward.

- Mr. Sievers reviewed the Capital Reserve Policy with the Board of Directors and made a motion to revise the Capital Reserve Policy as proposed, seconded by Mr. Shelton, all in favor, motion carried (07-003).
- Mr. Sievers made a motion to increase the meal allowances, from \$8, \$10 and \$18 to \$13, \$16 and \$25 respectively effective January 1, 2007, seconded by Mr. Shelton, all in favor, **motion** carried, (07-004).
- Still waiting to receive memorandum of understanding from Skagit County for court costs, and have not received it yet. Noted that NSMHA paid the first five months but will not pay future charges without the memorandum of understanding.

Mr. Sievers was thanked for his report.
