10. Report from the Planning Committee - Janelle Sgrignoli, Chair

Janelle Sgrignoli reported:

The Planning Committee met last week and is recommending \$1.1 million dollars from the Capital Reserve to be designated to improvements, upgrades, transition capacity issues, etc. Ms. Sgrignoli made a motion (#07-126) to accept the Planning Committee's recommendation for use of Capital Funds, seconded by Mr. Sievers, all in favor, motion carried.

11. Report from the Executive Director - Chuck Benjamin, Executive Director

Chuck Benjamin reported on:

- Transition plans for providers are moving forward, have run into some minor glitches and budgetary restraints, but have been able to work through them all. Thanked the providers for all of their hard work and collaboration on this.
- Three agencies bid for a drop-in agency in Snohomish County, although Sunrise Services dropped out so they could start one in Skagit County. Compass Health and bridgeways decided to not work together on the drop in center so Compass Health will start it alone.
- ➤ PACT (Program for Assertive Community Treatment), reported on programs starting and staff being hired and trained.
- > Stated Cindy Ainsley started on Monday as NSMHA's new Quality Manager
- RSN Certification Audit by MHD on September 17 and 18
- > The RFQ for Short-Term High Intensity Treatment services in Snohomish County will be re-let this month.
- Welcomed John Dean to the Board and stated

12. Report from the Finance Officer - Bill Whitlock, Fiscal Officer

Bill Whitlock reported:

The term of the contract is October 1, 2007 to June 30, 2009. Estimated annual funding is for this contract is \$213,665.

Motion #07-107

To review and approve contract NSMHA-SEA MAR-MEDICAID-07-09. The contract is for Medicaid covered mental health services to Medicaid enrollees based on the transition plan mutually agreed upon by Sea Mar and NMSHA. The term of the contract is October 1, 2007 to June 30, 2009. Estimated annual funding for this contract is \$644,133.

The contract is for the provision of mental health services to the non-Medicaid population and for the provision of non-Medicaid covered mental health services Medicaid enrollees based on the transition plan mutually agreed upon by Sea Mar and NSMHA. The term of the contract is October 1, 2007 to June 30, 2009. Estimated annual funding is for this contract is \$135,824.

Motion #07-109

To review and approve contract NSMHA-INTERFAITH-MEDICAID-07-09. The contract is for Medicaid covered mental health services to Medicaid enrollees based on the transition plan mutually agreed upon by Interfaith and NMSHA. The term of the contract is October 1, 2007 to June 30, 2009. Estimated annual funding for this contract is \$226,533.

Motion #07-110

To review and approve contract NSMHA-INTERFAITH-SMHC-07-09. The contract is for the provision of mental health services to the non-Medicaid population and for the provision of non-Medicaid covered mental health services Medicaid enrollees based on the transition plan mutually agreed upon by Interfaith and NSMHA. The term of the contract is October 1, 2007 to June 30, 2009. Estimated annual funding for this contract is \$59,343.

Motion #07-111

To review and approve contract NSMHA-LAKE WHATCOM-MEDICAID-07-09. The contract is for Medicaid covered mental health services to Medicaid enrollees based on the transition plan mutually agreed upon by Lake Whatcom and NMSHA. The term of the contract is October 1, 2007 to June 30, 2009. Estimated annual funding for this contract is \$626,711.

Motion #07-112

To review and approve contract NSMHA-LAKE WHATCOM-SMHC-07-09. The contract is for the provision of mental health services to the non-Medicaid population and for the provision of non-Medicaid covered mental health services Medicaid enrollees based on the transition plan mutually agreed upon by Lake

Whatcom and NSMHA. The term of the contract is October 1, 2007 to June 30, 2009. Estimated annual funding for this contract is \$1,242,927.

Motion #07-113

To review and approve contract NSMHA-WHATCOM COUNSELING AND PSYCHIATRIC CLINIC (WCPC)-MEDICAID-07-09. The contract is for Medicaid covered mental health services to Medicaid enrollees based on the transition plan mutually agreed upon by WCPC and NMSHA. The term of the contract is October 1, 2007 to June 30, 2009. Estimated annual funding for this contract is \$3,618,277.

Motion #07-114

To review and approve contract NSMHA- WHATCOM COUNSELING AND PSYCHIATRIC CLINIC (WCPC)-SMHC-07-09. The contract is for the provision of mental health services to the non-Medicaid population and for the provision of non-Medicaid covered mental health services Medicaid enrollees based on the transition plan mutually agreed upon by WCPC and NSMHA. The term of the contract is October 1, 2007 to June 30, 2009. Estimated annual funding for this contract is \$1,926,573.

Motions #07-099 thru #07-114 Chuck explained these are all the new provider contracts under the new system; similar to what we did 10 years ago, but better. Motion to approve by Mr. Williams, seconded by Ms. Sgrignoli, all in favor, motion carried.

To review for approval NSMHA-NAMI-FBG-06-07(1)AMENDMENT for the purpose of expending unspent FBG funds in the total amount of \$30,000 to provide a 4 month lease on the new drop in center facility in Skagit County. The maximum consideration for this contract is \$45,000.

Motion # 07-120

To review for approval for NSMHA-WCPC-FBG-07 for the purpose of expending unspent FBG funds in the total amount of \$15,000 to provide for the allowable purchase of appliances to improve the kitchen facility at the Rainbow Center. The maximum consideration for this contract is \$15,000.

07-119 – 07-120 Chuck explained this is a re-allocation already approved by the state so the money can be expended, Mr. Sievers moved approval, seconded by Mr. Tobey, all in favor, motion carried.

Motion #07-121

To review for approval DSHS-NSMHA-PIHP-0769-26002-07-09 for the provision of Medicaid services to enrollees of the North Sound Region. This agreement takes effect October 1, 2007 through September 30, 2009. Following the end of the annual legislative session, MHD will offer an amendment with the proposed rates for the next Fiscal Year. There is no maximum consideration for this contract as the rates are based on per member per month amounts.

Motion #07-122

To review for approval DSHS-NSMHA-SMHC-0769-26028-07-09 for the provision of state funded services to citizens of the North Sound Region. This agreement takes effect October 1, 2007 through September 30, 2009. Following the end of the annual legislative session, MHD will offer an amendment with the proposed rates for the next Fiscal Year. The estimated funding for this contract is \$ 40,777,852.

Chuck provided an overview of 07-121 and 07-122, Ms. LaBrash moved approval, seconded by Mr. Williams, all in favor, motion carried.

Motion #07-123

To review and approve DSHS-NSMHA-DDD-07-09 for the provision of crisis prevention and stabilization services to developmentally disabled individuals in the North Sound Region. This agreement takes effect October 1, 2007 through June 30, 2009. The estimated funding for this contract is \$628,346.

Motion #07-124

For approval of NSMHA-WCPC-DDD-07-09. This contract is to improve short-term, episodic crisis prevention, interventions and stabilization mental health services to registered DDD clients. The term of this contract is October 1, 2007 to June 30, 2009. Maximum consideration shall not exceed \$628,346

Chuck provided explanations for 07-123 and 07-124, Mr. Williams moved approval, seconded by Ms. LaBrash, all in favor, motion carried.

Motion #07-125

To introduce for review DSHS-NSMHA-MHBG-07-08. This contract is for the provision of services under the Federal Block Grant funding, the term of this agreement is October 1, 2007 through September 30, 2008. The estimated maximum consideration for this contract is \$983,871.

Chuck provided an overview and Ms. LaBrash moved approval, seconded by Ms. Sgrignoli, all in favor, motion carried.

Mr. Williams noted state meeting in Burien on September 28th on Criminal Justice and Mental Health (GAINS work) is an important conference and will most likely lead to legislation.
