To review and approve North Sound Mental Health Administration's claims paid from October 1, 2009 through October 31, 2009 in the amount of \$5,828,953.72. Payroll for the month of October in the amount of \$111,915.56 and associated employer paid benefits in the amount of \$41,618.42.

## Motion #09-161-AMENDED (See page 9 of the meeting packet)

To disperse \$590,592 of final Fee For Service unspent funding to providers who served over their contracted budget caps. Lake Whatcom will receive \$255,084; Bridgeways will receive \$173,787; and Sea Mar will receive \$161,721. In addition, increase the beginning budget caps available for earn-back toWhatcom Counseling & Psychiatric Clinic by \$27,248; Sunrise Services \$57,699; and Catholic Community Services by \$4,891.

## Motion #09-166

To approve NSMHA-ISLAND-ADMINISTRATION-10 for the provision of county participation on the coordination of and input regarding public mental health services within their county. The term of this Agreement is January 1, 2010 through December 31, 2010. The maximum consideration on this Agreement is \$51,318.

## Motion #09-167

To approve NSMHA-SKAGIT-ADMINISTRATION-10 for the provision of county participation on the coordination of and input regarding public mental health services within their county. The term of this Agreement is January 1, 2010 through December 31, 2010. The maximum consideration on this Agreement is \$55,164.

#### Motion #09-168

To approve NSMHA-SAN JUAN-ADMINISTRATION-10 for the provision of county participation on the coordination of and input regarding public mental health services within their county. The term of this Agreement is January 1, 2010 through December 31, 2010. The allocation of funding for this Agreement is inclusive of 15.25% of the San Juan County allocated jail transition funding for the coordination of services when requested by Island County. The allocated jail transition funding is \$6,748, for a maximum consideration on this Agreement of \$51,032.

## Motion #09-169

To approve NSMHA-WHATCOM-ADMINISTRATION-10 for the provision of county participation on the coordination of and input regarding public mental health services within their county. The term of this Agreement is January 1, 2010 through December 31, 2010. The maximum consideration on this Agreement is \$62,974.

#### Motion #09-170

To approve an INTERLOCAL AGREEMENT BETWEEN SKAGIT COUNTY and NSMHA for the provision of Fidelity Wraparound Services in Skagit County. The term of this Agreement is the date of execution through June 30, 2010. The maximum consideration on this Agreement is \$35,000.

#### Motion #09-171

To approve an INTERLOCAL AGREEMENT BETWEEN DIVISION of FAMILY SERVICES-CHILDRENS ADMINISTRTATION and NSMHA for the provision of Fidelity Wraparound Services in Skagit County. The term of this Agreement is November 12, 2009 through June 30, 2010. The maximum consideration on this Agreement is \$50,000.

#### Motion #09-172

To approve NSMHA-LAKE WHATCOM CENTER-PSC-10 for the provision of janitorial services for NSMHA office space. The term of this Agreement is January 1, 2010 through December 31, 2010. The maximum consideration for this Agreement is \$14,097.42.

#### Motion #09-173

To approve NSMHA-MCPP HEALTH CARE CONSULTING-PSC-09-10 for the provision of consultation services for crisis system planning and development of a crisis model for the region. The term of this Agreement is November 12, 2009 through June 30, 2010. The maximum consideration on the Agreement is \$30,000.

## Motion #09-174

To approve COMMUNITY HEALTH PLAN OF WASHINGTON-NSMHA-GAU-09-10 for the provision of level 2 mental health services in the North Sound. The General Assistance Unemployable (GAU) is a project to identify a population that does not have a mental health benefit currently, but needs mental health treatment. It is the intent of this project to identify those eligible for Medicaid and/or offer short term treatment to those who do not qualify. This contract is a pass through to our Community Mental Health Agencies participating in the GAU project. The number of estimated slots for North Sound is 97 with a maximum monthly payment of \$19,400.

#### Motion #09-175

To approve NSMHA-Skagit County-Settlement Agreement for the provision of Civil Commitment Legal Services. This Agreement provides \$140,400 for appropriate legal services provided from December 31, 2007 through September 30, 2009. A regional rate of \$200 per appropriate legal services will be paid commencing October 1, 2009.

#### Motion #09-176

To approve NSMHA-bridgeways-MEDICAID-09-11 Amendment 1 for the provision of an increase in Medicaid funding of \$34,296 for a new maximum on this Agreement of \$1,243,074.

## Motion #09-177

To approve NSMHA-CATHOLIC COMMUNITY SERVICES-MEDICAID-09-11 Amendment 1 for the provision of an increase in Medicaid funding of \$101,268 for a new maximum on this Agreement of \$5,303,109.

## Motion #09-178

To approve NSMHA-COMPASS HEALTH-MEDICAID-09-11 Amendment 1 for the provision of an increase in Medicaid funding of \$487,908 for a new maximum on this Agreement of \$29,078,235.

To approve NSMHA-INTERFAITH-MEDICAID-09-11 Amendment 1 for the provision of an increase in Medicaid funding of \$160,944 for a new maximum on this Agreement of \$652,239.

To approve NSMHA-LAKE WHATCOM RESIDENTIAL & TREATMENT CENTER-MEDICAID-09-11 Amendment 1 for the provision of an increase in Medicaid funding of \$311,600 for a new maximum on this Agreement of \$1,127,838.

To approve NSMHA-SEA MAR-MEDICAID-09-11 Amendment 1 for the provision of an increase in Medicaid funding of \$247,167 for a new maximum on this Agreement of \$1,547,259.

## Motion #08-182

To approve NSMHA-SUNRISE SERVICES-MEDICAID-09-11 Amendment 1 for the provision of an increase in Medicaid funding of \$68,460 for a new maximum on this Agreement of \$2,643,396. This Amendment is inclusive of a transfer of Supported Employment Funding from WCPC to Sunrise Services of \$108.000 annually.

#### Motion #09-183

To approve NSMHA-WHATCOM COUNSELING & PSYCHIATRIC CLINIC-MEDICAID-09-11 Amendment 1 for the provision of an increase in Medicaid funding of \$98,472 for a new maximum on this Agreement of \$5,232,720. This Amendment is inclusive of a transfer of Intensive Outpatient Funding from Sunrise Services to WCPC of \$108.000 annually.

## Motion #09-184

To approve the use of Medicaid funding for the Whatcom PACT to provide a funding model of 75% Medicaid funding to 25% State funding. This switch in funding is a direct result of the proposed budget cuts by DSHS-HRSA which cuts PALS funding to the RSNs.

Chair Dahlstedt asked if there were any revisions to the agenda. Dave Gossett asked to move Executive Session up on the agenda, to be held now for 20 minutes. It was stated that the purpose was to discuss potential litigation and Executive Session began at 1:35 with legal counsel; both present and via telephone. ## Report from the Executive/Personnel Committee

Dave Gossett reported:

- Mr. Gossett moved approval of the draft letter agreement to be sent to Skagit County, approve entry

- Still preparing for the External Quality Review in November, with extensive work involved
- Mental Health Division fiscal auditors will be here the 3<sup>rd</sup> week of October
- Have been busy with litigation

## 11. Report from the Finance Officer

Bill Whitlock reported:

- The current year revenue and expense report has some variances. The state funds short fall of \$551,959 is a permanent variance caused by the first round of budget cuts. The Detox pilot is a permanent variance because of the program was cancelled June 30, 2009. Federal Block Grant (FBG), PATH (Program for Assistance in Transition from Homelessness) and DDD (Division of Developmental Disabilities) variances are timing differences. The Professional Services variance of \$39,786 is a permanent variance due to legal costs. The utility variance of \$3,041 is a permanent variance along with the repairs and maintenance budget variance of \$481.
- Our insurance variance of \$10,545 is a permanent variance. This is an annual increase of over \$7,000. The increase is the largest in the last 10 years.
- We have been working with the state DSHS/HRSA on the actuarial rebasing process. We anticipate a 2.7% to 2.9% cut in the Medicaid rates based on original proposals. We received an overall 3% cut.
- We are presenting a preliminary budget for 2010.

Mr. Whitlock was thanked for his report.

- The finance committee met today and reviewed all claims for August and September that are before the board today
