7. Report from the Advisory Board

Marie Jubie reported:

- The Advisory Board met on September 7th.
- The Vice Chair acknowledged two new members from Whatcom County Mark McDonald and Howard "Hill" Cummings
- Minutes from August were approved as amended.
- Reports were received from:
 - Ombuds/Quality Review Team (QRT) Snapshot no representative present; however, information was included in the members manila folders
 - Finance Committee

- o Executive Committee
- Quality Management Oversight Committee (QMOC)
- Executive Director
- County Advisory Board members' reports
- Otis thanked the Board for the scholarship to attend the NAMI WA Conference and provided a brief regarding the conference.
- Chuck mentioned NSMHA is looking at between 4-7 % budget cut in October 2010 and an additional 10% cut in 2011. This will be approximately \$24.5 million statewide with \$3.5 million for NSMHA.
- The Advisory Board recommended approval of the Federal Block Grants (Motions 10-070 through 10-085), which includes the additional \$50,805 funds available due to contracts not being renewed.
- The next meeting will be October 12th.

Marie was thanked for her report.

8. Report from the Executive/Personnel Committee

Dave Gossett reported that due to scheduling conflicts, the November meeting of the NSMHA Board of Directors is cancelled.

9. Report from the Quality Management Oversight Committee

Anne Deacon reported:

- The meeting was held August 25, 2010, and no action was taken during this meeting as a quorum was not present.
- The following announcements were made:
 - An invitation was extended to providers to attend the next HCS/AAA/NSMHA meeting on September 1st from 10:00 to 12:00.
 - Anne mentioned the Office of Fiscal Management released a statement predicting more budget cuts of a minimum of 7%.
 - Greg mentioned the federal stimulus package was extended for another six months.
- The following Quality Issues were discussed:
 - o QMOC Process
 - Core Performance Indicators
 - o Semi-annual Critical Incident Report
 - o New Critical Incident Reporting Requirements
 - o Crisis Response by Intensive Outpatient Program (IOP) Teams
 - o Criteria for Policies that "Comply With" or are "Consistent With" NSMHA Policies
- The next meeting will be September 22, 2010, from 1-3.

Anne was thanked for her report.

10. Report from the Planning Committee

Anne Deacon reported:

- The Planning Committee met on September 2nd.
- Minutes from August were approved as written.
- Chuck mentioned the pending budget cuts and requested the Planning Committee agree with previous recommendations from stakeholder meetings. The committee agreed to accept recommendations from the stakeholder meetings.
- Margaret briefed the committee on the 2010-2011 Federal Block Grant (FBG) recommended allocations. The committee approved the recommendations. Chuck mentioned 13 RSNs have complained about the current FBG process.
- The B-3 Waiver statewide requirement changes were discussed.
- Regional Mental Health funding in light of State budget deficits was discussed.

- The Consumer Information System (CIS)/Sound Data System changes were discussed.
- Greg acknowledged a meeting was held with Home and Community Services, Area Agency on Aging, Division of Developmental Disabilities and NSMHA. Providers were extended an invitation to attend and several providers were in attendance. The meeting discussed/shared information not normally available and regular committee members thanked providers for their presence and willingness to share information.
- The next meeting will be October 8th.

Anne was thanked for her report.

11. Report from the Executive Director - Chuck Benjamin, Executive Director

Chuck Benjamin reported the Crisis System Implementation Committee is moving along, and is currently working on the fiscal component. NSMHA has asked that the fiscal complexities be built in and prioritized to get the most use of our funding. We are attempting to include mobile outreach which would have a huge impact on reducing hospitalizations. Briefly mentioned the $1/10^{th}$ of 1% sales tax monies to address local priorities to help offset costs and lessen the impact on all systems and counties. Chuck also stated that he appreciates the collaborative efforts of counties and NSMHA. Chuck was thanked for his report.

12. Report from the Finance Officer - Bill Whitlock, Fiscal Officer

Bill Whitlock reported:

- The Federal Block Grant and PATH (Project for Assistance in Transition from Homelessness) grant were low, \$202,739 and \$46,553, respectively. We think these are timing variances. The DDD billings are also behind with a timing variance of \$149,606. We have billed through July and only received payment through March. We are four months behind in receiving the funds. State funds have a permanent negative variance of \$752,114. Interest revenue was lower than budgeted due to the low interest rates. The negative variance is \$50,205. Overall, the revenues were a little higher in 2010 due to the low forecast of Medicaid funding in the NSMHA budget.
- We have a couple of issues with the current financial statements. Inpatient billings for June, July and August are not included in the information provided. In addition, the amounts on the bills were a lot lower than normal. We are tracking the Medicaid population payments from the state. June looks on target. Then July, August and September look low.
- The state is giving us a budget cut starting October 1, 2010. They call it a manual rate adjustment. The impact of this will be \$521,517 cut, annualized. We have attached a calculation showing our estimates. Note, this does not include the 4% to 7% cut proposed by the governor for the current state fiscal year.
- We have successfully changed banks from Chase to Skagit State and are in the process of closing out the old accounts at Chase.
- Cost Allocation Plan: Bill reviewed the plan with the Board, noting that it was passed by the Planning Committee in June and stated that Finance Committee will be asking the Board to adopt this today. Brief discussion ensued on how the cost allocation plan was developed. Bill noted that it was based on statistics or regulations. Ken Stark added this plan is not new; NSMHA has been following all of the state and federal regulations. What this does is document that we have followed the process.

Bill was thanked for his report.

13. Report from the Finance Committee - Ken Stark, Chair

Ken Stark moved **Motion #10-095** adopting the cost allocation plan, seconded by Jackie Henderson, all in favor, **motion carried**.

The group will coordinate and collaborate, developing common priorities, or agree to fund separate services, etc. and is inviting NSMHA to join this group as NSMHA is a funder of Snohomish County Human Services.
