NSMHA is proposing renting a small, three-bedroom house next door to the Compass Health's Bailey Center where the crisis center is located to provide transitional housing. Any CMHA serving consumers coming out of WSH could utilize this house for one of their consumers. Their case manager, housing specialists, and other staff would work with the consumers on an intensive basis to find them housing and support their re-establishing themselves in the community. People would be authorized to stay in these beds for up to 30 days. An individual could have up to two re-authorizations. People would have to leave after 90 days. The budgeted cost of this program is \$31,180/yr. Effective date is November 1, 2011.

- The meeting was held on August 24, 2011; there was no meeting in July.
- The following announcements were made:

  - o Fred Plappert presented his agenda item on risk assessments at facilities for those who are a danger to themselves.
  - o Marie Jubie asked for clarification on appointments to committees by the Advisory Board and it was noted that the Advisory Board nominates both board members and at large representatives as well.
  - o Greg passed out information on the Partnership Access Line (PAL), a child psychiatric phone consult resource available throughout the State for providers.
- The following Quality Issues were discussed:
  - Recommendation to continue the use of the CA/LOCUS tool; to be revisited in the event the State changes the tool.
  - Recommendation to select planful discharge from services as the new PIP.
  - o Update on the Motivational Interviewing Training and the overwhelming response.
  - o Information on the customer service survey to be conducted the last two weeks of October.
  - o Recommendation to approve three policies: 1702 1719 1562.
  - o The semi-annual CIRC and second opinion reports were presented.
  - o An update was given on the success of the WCPC Open Access Process.

Anne Deacon reported:

- The Planning Committee met on September 16<sup>th</sup>
  - o Reviewed additional funding for the following programs:
    - Skagit county half PACT,
    - WRAP and CHAP (Respite Care funding)
    - transitional housing,

- WCPC asked for additional funding for the Elder Gatekeeper program and after robust discussion the recommendation to fund this program was not supported.
- Revised the Planning Committee Charter to define a quorum
- Next meeting is October

Ms. Deacon was thanked for her report.

## 11. Report from the Executive Director

Chuck Benjamin reported:

- NSMHA Staff have been working very hard to get the contracts before the Board today completed
- NSMHA was on a conference call yesterday with Secretary Dreyfus, it was a doom and gloom call regarding the budget deficit and funding reductions
  - O Looking at initially closing two wards at Western State Hospital (each ward costs the state \$3.5 million to operate and it will be interesting to see what comes back to the communities)
  - Later closing three other wards, and stating funding will come to the communities to develop local resources, but not defining how much money. Group discussed how the reductions are really costshifts
  - O Looking at decreasing the number of eligibles, along with a rate reduction (a \$5 million negative impact just from rate reduction for this Region).
  - O Definition of vulnerable population is being looked at for redefining from "people at risk of not being able to care for themselves" to "not being able to care for themselves"
  - o Adult pharmaceuticals being eliminated unless in an institutional setting/jails
  - o Reducing the number of RSN's to a total of 4-6, stating there would be approximately \$3 million dollar savings by reducing the number of RSN's.
- RFP for the Skagit county Peer Center will be released soon, with a recommendation to come to this Board at the December 8<sup>th</sup> with a February 1, 2012 start date; brief discussion followed on triage centers in Skagit and Snohomish counties

Mr. Benjamin was thanked for his report.

## 12. Report from the Finance Officer

Bill Whitlock reported:

- The revenue and expense report is through August 2011. The Federal Block Grant and PATH (Project for Assistance in Transition from Homelessness) and DDD grants were low. They have negative variances of \$232,682, \$73,963 and \$59,842 respectively. These are most likely timing variances. The rest of the revenue variances are all permanent variances. Interest revenue was lower than budgeted due to the low interest rates. Overall, the revenues are just over a million dollars lower than in 2010.
- The PALS (Program for Adaptive Living Skills) funds were reduced in 2011. The PACT (Program for Assertive Community Treatment) variance is because the funds were switched to mostly Medicaid funded in May. This is per the State budget proviso. This was not a budget reduction like we thought might happen last year.
- The negative expenditure variances are in benefits and insurance.
- Provider expenditures are over budget by just over \$2.8 million. Inpatient billings are over budget by just over \$984,000. The inpatient expenditures are about twice as much as last year. We think this is Provider One clearing out some of last year's bills.
- There are motions coming from the Planning Committee that are also fiscal issues. We are requesting to put additional state funds into the budgets. The changes are restoring prior cuts, new programs and \$3.5 million in fee for service programs to fund historical over service. Unfortunately, the state announced major budget cuts on Monday. This means we need to go through another planning process to reduce expenditures to the proposed revenue cuts.
- The Planning Committee also recommended the format for the fee for service payout for the end of the two year budget cycle. The payout is based on provider audit scores and service over the budget cap.

• We completed our audit from the State Auditor's Office. There were no findings and were some recommendations. Next week we host the DSHS/DBHR fiscal auditors.

Mr. Whitlock was thanked for his report.
