David reported on the February 2<sup>nd</sup> Advisory Board meeting and discussed the pre-meeting presentation the Advisory Board received on Skagit County Juvenile Justice Youth Court and Substance Use Disorder Youth Program. David noted Advisory Board brief is located behind Tab 1, and David was thanked for his report.

### 8. Committee Reports

Chair Dahlstedt noted the Quality Management Oversight Committee Report is located behind Tab 2.

### 9. Report from the Executive Director

Joe said we would hear from NSMHA legal counsel, Brad Furlong regarding our transition to a Limited Liability Corporation and also the planning agreements we are working on with the Skagit, Snohomish and Whatcom counties for the purpose of replacing behavioral health facilities. Brad addressed the Board of Directors and said he received the Certificate of Formation from the Secretary of State legally recognizing our conversion to a Limited Liability Corporation as of February 4, 2016. Brad noted we would continue to operate functionally until April 1<sup>st</sup> as a Regional Support Network and then provided all contracts are in place will operate as a Behavioral Health Organization as of April 1<sup>st</sup>. Brad said this is a time of big change and complimented Joe and North Sound Staff as well as staff in his office, attorney Laura Minton-Breckenridge and legal assistant Sarah Hastings as well as the counties respective Deputy Prosecuting Attorneys all being instrumental in moving this process along.

Brad distributed the Outline of Regional Agreement Concerning Facility Planning and reviewed the document with the Board, discussing the major tasks, schedule, funding of tasks, leadership and governance along with duration of the agreement. Discussion took place throughout Brad's presentation and touched on reuse of existing facilities and whether the language in section 3 would allow those funds to be used for remodeling existing facilities. Brad said repurposing existing structures and sites could be ideal, helping to reduce communication issues or resistance from the public as well as construction costs. There was also concern expressed around meeting the proposed timeline; Brad said the timeline could always be extended although the hope would be to conduct the work within the timeline noted. Joe noted that North Sound is providing the capital seed dollars and seeking additional funding from the legislature. David Kincheloe asked about the Communications Plan and expressed interest in being involved with that. Discussion touched on Facility Site Acquisition and clarifying the role of the County.
