Northwest Regional Council

This Professional Service Contract is to cover startup costs for In-Home Behavioral Health Services beginning on October 1, 2018. Funding will cover hiring, training, computers and any other costs associated with starting up the services.

Motion #18-90

Evergreen Recovery Centers

Legacy House in Mount Vernon is a male residential facility, beds became available on June 27, 2018. The funding being provided in this amendment will cover the operations of the facility through December 31, 2018.

Center for Human Services

This professional service contract is paying for startup costs CHS incurred developing the Wraparound with Intensive Services (WISe) team. The team is school based and located in South Snohomish County. The team is currently active and serving youth.

Compass Health

This amendment encompasses the following changes to the contract:

- Removing the three (3) Chemical Dependency Professionals from the Crisis Prevention and Intervention teams in Skagit, Snohomish and Whatcom Counties, the cut is due to state funding shortfalls;
- Adding four (4) staff to the Crisis Prevention and Intervention team to work with Law Enforcement, the additional funding is ESSB 6032 enhancement funding received from the State;
- Adding two (2) court liaisons in Whatcom County to take over the liaison role which was previously performed by staff at PeaceHealth/St. Joe's hospital.

Motion #18-93

- North Sound BHO-Compass Health-BHSC-16-18 Amendment 14 to decrease funding by \$50,210 for a new maximum consideration of \$16,102,293.98 with a term of April 1, 2016 through December 31, 2018.
- North Sound BHO-Compass Health-Medicaid-16-18 Amendment 12 to decrease funding by \$77,787 for a new maximum consideration of \$78,372,339 with a term of April 1, 2016 through December 31, 2018.

Snohomish County Humans Services

The funding increase to this contract is for the planning stages of the new Denny Way Treatment Center. This is Medicaid funding which the county will match with 9% local funds.

Motion #18-94

North Sound BHO-Snohomish County-Medicaid-16-18 Amendment 4 to increase the contract by \$88,000 with a new maximum consideration of \$6,476,294 with the term remaining the same April 1, 2016 through December 31, 2018.

Unity Care NW

Unity Care NW will begin serving children/youth in their mental health outpatient program. They currently serve adults and transition age youth.

North Sound BHO-Unity Care NW-Medicaid-16-18 Amendment 2 to increase funding in the contract by \$74,250 for a new maximum consideration of \$1,941,423 with the term remaining the same April 1, 2016 through December 31, 2018.

Volunteers of America (VOA)

Due to the shortfall in state funds, VOA has had a reduction in force. The Access Line staff was cut by two (2) FTE. The Access Line is still operational; however, individuals/families are directed to an online access form. Individuals/families are calling providers directly for access to services in most instances.

Motion #18-96

Glenn Lippman, M.D

Dr Lippman is transitioning to the North Sound BHO as our consulting Medical Director. Dr. Lippman is well versed in managed care and has been on contract previously with the North Sound BHO. Dr Brown has taken the full-time position as Medical Director for Community Health Plan of Washington (CHPW). CHPW and North Sound BHO believe conflicts of interest will arise if Dr. Brown were to continue as our consulting Medical Director.

Introduction

XPIO

XPIO is an information management company that is assessing the BHO and its provider network's level of readiness to transition to an integrated managed care model, focusing on system and organizational capabilities required to meet anticipated operational, clinical, financial, regulatory and organizational needs. The BHO will receive funding from the Accountable Communities of Health for this project, we have requested and been approved to receive mid-adopter incentive funds.

Motion #18-105

 North Sound BHO-XPIO-PSC-18 for the assessment and evaluation of information system needs in the North Sound Region. The maximum consideration on this contract is up to \$504,000 with a term of July 1, 2018 through December 31, 2018.

Joe noted this is a sole source contract, the only entity that is doing this work. They are assisting other BHOs as well. Regina Delahunt moved the motion for approval, Jamie Stephens seconded, all in favor, motion #18-105 carried.

Introduction

Health Management Associates (HMA)

HMA is a consultation firm working with the BHO to facilitate meetings with BHO Leadership to accomplish Integrated Managed Care strategic planning and transition year implementation. This is Phase I of a two phase project, Phase II will

be designed at the completion of Phase I, which is tentatively scheduled for completion on or before September 30, 2018.

Motion #18-106

North Sound BHO-HMA-PSC-18 for Phase I of the planning and implementation of integrated managed care.
The maximum consideration on this contract is \$25,000 with a term of July 1, 2018 through September 30, 2018.

Introduction

State Targeted Opioid Response Grant (STR)

This grant assists uninsured/underinsured individuals to access Opioid Use Disorder (OUD) Treatment. The two contracts listed are the HCA contract with the BHO and the BHO contract with Catholic Community Services NW (CCSNW) who provides the direct service. Eligibility criteria is 221%-400% of the federal poverty level.

Motion #18-98

- HCA-NS BHO-STR-2018 to provide funding for OUD treatment to individuals meeting the eligibility criteria. The maximum consideration on the contract is \$24,252 with a term of May 1, 2018 through December 31, 2018.
- NS BHO-CCSNW-STR-2018 to provide funding for OUD treatment to individuals meeting the eligibility criteria. The maximum consideration on the contract is \$24,252 with a term of May 1, 2018 through December 31, 2018.

Introduction

Substance Use Disorder Community Partnership

This funding is "backfill" for the Designated Marijuana Account (DMA) funds. Due to a cut in our allotment of DMA funds we are providing counties with state funds to cover six (6) months, July 1, 2018 through December 31, 2018. These funds provide prevention/intervention services in the local school districts. This is Medicaid funding with the counties are responsible for a 9% match with local funds.

Motion #18-99

 North Sound BHO-Island County-PSC-18 for the purpose of providing funds to continue services under the designated Marijuana account school-based prevention activities. The maximum consideration on this contract is \$93,236 with a term of July 1, 2018 through December 31, 2018.

- North Sound BHO-San Juan County-PSC-18 for the purpose of providing funds to continue services under the designated Marijuana account San Juan County community collaborative activities. The maximum consideration on this contract is \$142,600 with a term of July 1, 2018 through December 31, 2018.
- North Sound BHO-Skagit County-PSC-18 for the purpose of providing funds to continue services under the designated Marijuana account school-based prevention activities. The maximum consideration on this contract is \$240,000 with a term of July 1, 2018 through December 31, 2018.
- North Sound BHO-Snohomish County-PSC-18 for the purpose of providing funds to continue services under the designated Marijuana account school-based prevention activities. The maximum consideration on this contract is \$193,305 with a term of July 1, 2018 through December 31, 2018.
- North Sound BHO-Whatcom County-PSC-18 for the purpose of providing funds to continue services under the designated Marijuana account school-based prevention activities. The maximum consideration on this contract is \$115,506 with a term of July 1, 2018 through December 31, 2018.

Introduction

Family Youth System Partner Roundtable (FYSPRT)

FYSPRT is to continue to develop, promote and support the Regional FYSPRT to align with the Washington State Children's Behavioral Health Principles and the FSYPRT manual. Skagit County holds the contract with the BHO for the regional FYSPRT. The county contract has funding through December 31, 2018.

Motion #18-100

HCA-North Sound BHO-FYSPRT-17-18 Amendment 2 for funding the FYSPRT through December 31, 2018. The increase to the contract is \$37,500 for a new maximum consideration of \$200,250 with the term of the contract extended by six (6) months for a new term of April 1, 2016 through December 31, 2018.

Jamie Stephens moved the motion for approval, Ken Dahlstedt seconded, all in favor, motion #18-100 carried.

Amendment 4 is adding Criminal Justice Account Treatment funding to provide four (4) individuals to attend a National Association of Drug Professionals National Conference. The funding was used for partial scholarships for Superior Court staff to attend, the county matched the costs with local funds.

The Relias Learning System is available to our provider network for professional development and maintaining hours/credits for licensure/certification.  Relias Learning LLC-North Sound BHO LLC-Master Services Agreement Renewal and Upgrade 2018-2020. The two-year maximum consideration on this agreement is \$357,976.88 with a term of August 1, 2018 through July 31, 2020.
