Based on the Agreement of the parties to the above-referenced Contract between the North Sound Behavioral Health Administrative Services Organization, LLC (North Sound BH-ASO) and Mount Baker Presbyterian Church (Contractor) dated November 15, 2023, is hereby amended as follows:

The purpose of this amendment is to provide funding for Opioid Outreach in the amount of \$235,000.00 for July 1, 2024 to June 30, 2025:

By mutual agreement of the parties, the following language is added to the agreement:

- Replace *Exhibit F – Federal Subaward Identification* with *Exhibit F(a) – Federal Subaward Identification*
