#### CONTRACT #NORTH SOUND BH-ASO-COMPASS HEALTH-ICCN-19-22

Based on the Agreement of the parties to the above-referenced Contract between the North Sound Behavioral Health Administrative Services Organization, LLC (North Sound BH-ASO) and Compass Health (Provider) dated March 26, 2019, (as amended by North Sound BH-ASO and Provider dated October 7, 2021, collectively the "Contract") is hereby amended as follows:

The purpose of this amendment is to continue funding and add San Juan County HARPS funding for the period of January 1, 2022, through June 30, 2022.

By mutual agreement of the parties, the following exhibit is added to the agreement:

- 1. Replace NS BH-ASO Compass Budget 2021-E with NS BH-ASO Compass Health Budget 2022-F
- 2. Replace Section 5.2.5.5.2 with the following: The Provider shall submit an invoice within 30 days from the service month (i.e., services in June invoiced on or before August 1st) along with all accompanying reports as specified in the attached exhibit(s), including its final invoice and all outstanding reports. The North Sound BH-ASO shall initiate authorization for payment to the Provider not more than 30 days after a timely, complete and accurate invoice is received.

ALL TERMS AND CONDITIONS OF CONTRACT SHALL REMAIN IN FULL FORCE AND EFFECT.

THIS AMENDMENT IS EXECUTED BY THE PERSONS SIGNING BELOW, WHO WARRANT THAT THEY HAVE THE AUTHORITY TO EXECUTE THIS AMENDMENT.
