CONTRACT AMENDMENT 3**

CONTRACT # NORTH SOUND BH-ASO-OPPORTUNITY COUNCIL-CBRA-23

Based on the Agreement of the parties to the above-referenced Contract between the North Sound Behavioral Health Administrative Services Organization, LLC (North Sound BH-ASO) and Opportunity Council (Provider) dated July 27, 2023, (as amended by North Sound BH-ASO and Provider dated July 30, 2024, collectively the "Contract") is hereby amended as follows:

The purpose of this amendment is to provide additional Proviso 86 Behavioral Health Rental Assistance funding in the amount of \$120,000 for July 1, 2024 to June 30, 2025:

By mutual agreement of the parties, the following language is added to the agreement:

- Replace *Exhibit B(b) - Opportunity Council CBRA Budget* with *Exhibit B(c) – Opportunity Council CBRA Budget*

ALL TERMS AND CONDITIONS OF CONTRACT SHALL REMAIN IN FULL FORCE AND EFFECT.
