CONTRACT # NORTH SOUND BH-ASO-SNOHOMISH COUNTY SUPERIOR COURT-ICN-23

Based on the Agreement of the parties to the above-referenced Contract between the North Sound Behavioral Health Administrative Services Organization, LLC (North Sound BH-ASO) and Snohomish County Superior Court (Provider) dated February 23, 2023, (as amended by North Sound BH-ASO and Provider dated August 7, 2024, collectively the "Contract") is hereby amended as follows:

The purpose of this amendment is to provide additional Juvenile Treatment Services funding for July 1, 2024 to June 30, 2025.

By mutual agreement of the parties, the following language is added to the agreement:

- Replace *Exhibit E(b) - Snohomish County Superior Court_Budget_ICN* with *Exhibit E(c) - Snohomish County Superior Court_ICN_Budget*

ALL TERMS AND CONDITIONS OF CONTRACT SHALL REMAIN IN FULL FORCE AND EFFECT.
