SUBJECT: CLINICAL PRACTICE GUIDELINES

PURPOSE

To ensure that North Sound Behavioral Health Administrative Services Organization (BH-ASO) and its Provider Network adopt and utilize Practice Guidelines to enhance the quality of care to individuals through the use of those Practice Guidelines for clinical decision making.

DEFINITIONS

<u>Emerging Technology</u> is an approach that is currently being developed or will be developed within a reasonable time frame (such as the next five to ten years). The new approach will substantially alter healthcare environment and may include (but not be limited to) information systems (such as Electronic Health Records), communications, somatic treatments (medications or direct interventions) and biotechnologies.

<u>Evidence-Based Practice</u> means a program or practice that has been tested where the weight of the evidence from review demonstrates sustained improvements in at least one outcome. "Evidence-based" also means a program or practice that can be implemented with a set of procedures to allow successful replication in Washington and, when possible, is determined to be cost-beneficial.

<u>Practice Guideline</u> is a systematically developed statement designed to assist in decisions about appropriate behavioral health treatment. The guidelines are intended to assist practitioners in the prevention, diagnosis, treatment and management of clinical conditions.

POLICY

North Sound BH-ASO will ensure, through its contracts, that each provider contracted within the network adopts and adheres to the North Sound BH-ASO clinical practice guidelines approved by the North Sound BH-ASO Medical Director and Leadership Team.

Clinical practice guidelines will be compliant with all State and Federal standards and requirements. Providers will utilize these practice guidelines as a training and supervision tool for direct clinical staff in accordance with their contracts. North Sound BH-ASO shall ensure adherence to this requirement through review of personnel charts during administrative audits.

Decisions for utilization management individual education, coverage of services, service delivery and other areas to which the guidelines apply will be consistent with their content.

North Sound BH-ASO will also participate in the evaluation of emerging technologies for the treatment of behavioral health conditions and related decisions as directed by the Health Care Authority (HCA) and as requested by the Managed Care Organizations (MCOs) it contracts with.

PROCEDURES

- 1. North Sound BH-ASO will, under the oversight of its Medical Director, adopt clinical practice guidelines known to be effective in improving outcomes. They will be adopted through a collaborative process with the BH-ASO Clinical, Utilization and Quality Management programs. They will then be presented by the North Sound BH-ASO Medical Director to the North Sound BH-ASO Leadership Team for approval. Practice guidelines shall be based on the following:
 - a. Valid and reliable clinical scientific evidence;
 - b. In the absence of scientific evidence, professional standards; or
 - c. In the absence of scientific evidence and professional standards, a consensus of Health Care Professionals in the particular field.
- North Sound BH-ASO will adopt guidelines from recognized sources that develop or promote evidence-based clinical practice guidelines such as voluntary health organizations such as the American Psychiatric Association (APA) or the American Academy of Child and Adolescent Psychiatry (AACAP), National Institute of Health Centers, or Substance Abuse Mental Health Services Administration (SAMHSA).
- 3. If North Sound BH-ASO does not adopt guidelines from recognized sources, board-certified behavioral health providers must participate in the development of the guidelines. The guidelines shall:
 - a. Consider the needs of Individuals and support Individual and family involvement in care plans;
 - b. Be implemented in concert with the ethnic, cultural and linguistic characteristics of its Individuals;
 - c. Be adopted in consultation with contracting Behavioral Health Professionals within the state of Washington;
 - d. Be reviewed and updated at least every two (2) years and more often if national guidelines change during that time to ensure their ongoing compliance with requirements and clinical relevance;
 - i. These reviews will be under the oversight of the BH-ASO Medical Director.
 - ii. As often as possible, the clinical guidelines will encompass internet links to APA and AACAP 's accepted and published clinical practice guidelines, which are self-updating.
 - e. Be disseminated to all affected providers (including GFS and FBG providers) and, upon request, to HCA and Individuals. In addition, The BH-ASO will make them available on North Sound BH-ASO website.
- 4. Provider utilization of North Sound BH-ASO clinical practice guidelines will be ensured by inclusion of this requirement in provider contracts and through ongoing oversight and monitoring to core elements of each guideline, as appropriate, during utilization review and administrative and clinical audits.
- 5. The North Sound BH-ASO Medical Director will participate in the evaluation of emerging technologies for the treatment of behavioral health conditions and related decisions. North Sound BH-ASO will also have a Child or Adolescent Psychiatrist available for consultation related to other emerging technologies for the treatment of behavioral health conditions in children and youth.
