Delivering PFA

When delivering PFA: Observe first Ask simple respectful questions Speak calmly and slowly without jargon Be patient, responsive, and sensitive Acknowledge the survivor's strength

Some Behaviors to Avoid

• When delivering PFA avoid:

- Making assumptions about experiences
- Assuming everyone will be traumatized
- Labeling reactions as "symptoms," or speaking in terms of "diagnoses"
- Talking down to or patronizing the survivor

Quality Management Oversight Committee (QMOC) Brief September 13, 2017

Disaster Planning

Michael McAuley, North Sound BHO

Michael McAuley checked in with providers to see how disaster planning is going. Brief conversation ensued regarding how disaster planning is progressing at respective agencies.

Policy 1726.00 – Involuntary Treatment Program Court Liaison Role and Responsibilities Michael McAuley, North Sound BHO

Policy 1726 was developed to ensure consistent practice in this function in the region. This policy was due for review and small revisions. One change in practice is the need for the provider agencies, contracted to provide Involuntary Treatment Act (ITA) services, to submit hearing outcome. This is a requirement from the State, per RCW, which required a change to the policy. Data elements had to be changed to allow the information to be transmitted. This was addressed by the CIS workgroup, with the change being made. QMOC voted to approve this policy.

Policy 1535.00 – Law Enforcement Coordination for Community Referrals Michael McAuley, North Sound BHO

This is a new policy created by the ICRS workgroup, and reviewed and approved by ICRS. The policy was created after passage of a new bill (HB 1448), established to better support Law enforcement officers in the field. The purpose of this policy is to ensure Designated Mental Health Professionals/Designated Crisis Responders(DMHP/DCR) are working in a coordinated effort with law enforcement (LE) and other appropriate providers following a LE outreach, where LE refers an adult, who has threatened or attempted suicide, but has remained in their home. The intent of the bill is to attempt to address the risk and provide needed behavioral health follow up. These procedures are not an intended substitute for high acuity crisis situations when more immediate outreach or intervention is required. This law created a need for specific procedures at the DMHP offices, when a referral was made. Conversation ensued regarding the lack of specificity in the policy and the policy will be brought back to QMOC after further revision.

Policy 1529.00 - Children's Long-Term Inpatient (CLIP)

Angela Fraser-Powell, North Sound BHO

In mid-2016, the state made significant contract changes to the requirements of the BHO where CLIP treatment is concerned. The changes were so significant, not only did it require a near complete re-write of the BHO's current policy but will also involve a care coordination piece on the part of our providers when a youth is admitted into CLIP. QMOC voted to approve this policy.

Policy 1531.00 – Consumer Employment Services

Christopher Allen, North Sound BHO

Recommendation was made for Policy 1531, Consumer Employment Services, to be archived. This policy is extremely out of date, and was written at a time when we had a type of employment services that are no longer available. While we continue to expect that agencies offer referrals and other assistance with individuals' employment related needed, we believe these expectations are communicated in the Recovery/Resiliency Planning policy. QMOC approved this policy for archive.

Policy 1551.00 – Outpatient Recovery and Resiliency Plans / Individual Service Plans

Kurt Aemmer, North Sound BHO

This policy was due for update due to changes to the Washington Administrative Code (WAC) and contract changes. This policy was also updated to reflect "BHO" language. Brief conversation ensued regarding Recovery and Resiliency Plans. There was one slight modification to the policy after discussion. QMOC approved this policy with the discussed modification.

Special Populations Consultant Roster Update

Kurt Aemmer, North Sound BHO

Kurt Aemmer provided a brief reminder regarding the email that was sent to providers requesting an update of the 2015 Special Populations Consultant Update. Kurt has requested that providers provide copies of their most recent roster by September 20, 2017.

Please find for your review the following that will go before the North Sound BHO County Authorities Executive Committee Meeting at the October 12th, 2017 meeting:

For Executive Committee Approval:

Professional Service Contracts

- Asian Counseling & Treatment Services (ACTS) is a new Substance Use Disorder provider in South Snohomish County serving a niche population. The funding is for startup costs, with an emphasis on modifying their data system and staff training, which began in March 2017.
- Northshore Youth & Family Services (NSYFS) is a Substance Use Disorder provider serving youth in the Northshore School District. This funding is to pay for additional staff to serve the Medicaid population in the Northshore School District.
- Catholic Community Services NW (CCS NW) is requesting an additional \$29,742.93 to complete the remodel of their new offices in Burlington WA. The increase reflects extra demolition and construction to move rest rooms to ground level for ADA accessibility as a ramp would not work in the space available. The fire marshal is also requiring a concrete divider where a welded steel door currently divides CCS space from the space next door.

North Sound BHO-ACTS-PSC-17 for the purpose of funding startup costs for preparation for contracting with the North Sound BHO. The maximum consideration on this contract is \$65,019.99 with a term of March 1, 2017 through December 31, 2017.

North Sound BHO-NSYFS-PSC-17 for the purpose of funding startup costs for preparation for contracting with the North Sound BHO. The maximum consideration on this contract is \$10,000 with a term of October 1, 2017 through December 31, 2017.

North Sound BHO-CCSNW-PSC-17 Amendment 1 for the purpose of increasing funding by \$29,742.93 for a new maximum consideration of \$190,205.93 with the term of the contract remaining the same August 1, 2017 through December 31, 2017.

Wraparound with Intensive Services (WISe)

• The case rate for WISe services is being increased from \$3,400 to \$3,900 to reflect actual costs of the WISe program for Compass Health in Island and Snohomish Counties.

North Sound BHO-Compass Health-WISe16-18 Amendment 3 for the purpose of increasing funding by \$681,000 for a new maximum consideration of \$12,084,600 with the term of the contract remaining the same April 1, 2016 through March 31, 2018.

Snohomish County Crisis Triage

• Funding is being increased to Compass Health for the Snohomish County Triage Center to reflect actual costs for the capacity funded program. The funding is being provided to increase unit clerk staffing for 24x7 coverage, including weekends.

North Sound BHO-Compass Health Triage-16-18 Amendment 3 for the purpose of increasing funding by \$532,000 for a new maximum consideration of \$10,127,176 with the term remaining the same April 1, 2016 through March 31, 2018.

Evaluation and Treatment Center

• Funding is being increased for the Snohomish County Evaluation & Treatment Center to reflect actual costs for the capacity funded program. The funding is provided to add three FTE personnel for data entry and correction for a budgetary error on the pass-through funding for Snohomish County to pay for facility improvements.

North Sound BHO-Compass Health-E&T-16-18 Amendment 5 for the purpose of increasing funding by \$1,159,440 for a new maximum consideration of \$10,729,916 with the term remaining the same April 1, 2016 through March 31, 2018.

Behavioral Health State and Medicaid Contracts

- Compass Health funding is increased for Crisis Services and Residential Services to reflect actual costs for the capacity funded programs. The funding is covering the increase in operating costs for Aurora, Haven and Green House residential facilities. The funding is also covering the increase in costs for the Crisis Prevention Intervention Teams and ITA services.
- Asian Counseling and Treatment Services (ACTS) is a new Substance Use provider in South Snohomish County. The contract is for the services ACTS will provider on behalf of the North Sound BHO.
- Northshore Youth & Family Services (NSYFS) is a new Substance Use provider serving youth in the Northshore School District (Bothell). The contract is for the services NSYFS will be providing on behalf of the North Sound BHO.

North Sound BHO-Compass Health-BHSC-16-18 Amendment 10 for the purpose of increasing funding by \$136,374 for a new maximum consideration of \$11,971,445.98 with the term of the contract remaining the same April 1, 2016 through March 31, 2018.

North Sound BHO-Compass Health-Medicaid-16-18 Amendment 9 for the purpose of increasing funding by \$928,722 for a new maximum consideration of \$55,096,266 with the term of the contract remaining the same April 1, 2016 through March 31, 2018.

North Sound BHO-ACTS-BHSC-17-18 for the purpose of providing Substance Use Disorder outpatient services in South Snohomish County. The maximum consideration on this contract is \$ with a term of October 1, 2017 through June 30, 2018.

North Sound BHO-ACTS-Medicaid-17-18 for the purpose of providing Substance Use Disorder outpatient services in South Snohomish County. The maximum consideration on this contract is \$ with a term of October 1, 2017 through June 30, 2018.

North Sound BHO-NSYFS-BHSC-17-18 for the purpose of providing Substance Use Disorder outpatient services to youth in the Northshore School District. The maximum consideration on this contract is \$ with a term of October 1, 2017 through June 30, 2018.

North Sound BHO-NSYFS-Medicaid-17-18 for the purpose of providing Substance Use Disorder outpatient services to youth in the Northshore School District. The maximum consideration on this contract is \$ with a term of October 1, 2017 through June 30, 2018.

For Executive Committee Ratification:

Snohomish County Drug Court

 Funding has been received to continue the juvenile drug court program in Snohomish County. This amendment continues the program through June 30, 2018. The funding has historically been contracted directly through the State to Snohomish County.

North Sound BHO-Snohomish County Superior Court-16-18 Amendment 1 for the purpose of providing the 2018 funding and extending the contract end date. The increase in funding is \$139,800 for a new maximum consideration of \$271,996 with an extended term of April 1, 2016 through June 30, 2018

North Sound BHO Executive Directors Report For the Advisory Board October 3, 2017

Integration Planning Update

- On October 5, there will be a special meeting of the BHO County Authorities Executive Committee to hear reports back from each of the counties on their decision to become a midadopter. If all 5 counties agree to become a mid-adopter, then the BHO CAEC will vote on sending a letter of intent to the Health Care Authority.
- It's likely that the Counties want to attach conditions to any letter of intent to become a midadopter [see attached draft agenda for the October 5 CAEC meeting.]
- Snohomish, Island, and Whatcom county councils/commissions have already voted to support becoming mid-adopters. Skagit County Commissioners and San Juan County Council have discussed the issue in work sessions and are scheduled to take a final vote on October 3.
- The Counties must also send in a letter of intent to become a "Behavioral Health Administrative Services Organization [BH-ASO].
- At a minimum, a BH-ASO has a separate contract with state to provide Crisis and Non-Medicaid Services. However, the North Sound would like to continue to contract with the MCOs to continue to support a wider array of specialized services.

Behavioral Health Facilities Update

- BHO staff continue to work with Skagit County staff and the contracted Behavioral Health Facilities project manager, Cumming, to identify potential locations in Skagit County for a future "Stabilization Campus" where both the future Evaluation and Treatment Facility and an Acute Detox Center could be located. A specific location north of Burlington has been identified that we are in the process of arranging for environmental assessments on.
- We are in the process of selecting an architectural firm that would develop the proposed facility model and estimated costs.
- Another possible location for the "Tri-County" facility has been identified as well that will need to be assessed.
- An alternative potential location in Oak Harbor for the proposed Tri-County Crisis Center has also been identified that will be explored further. It would require that Island County purchase all or a part of the property.

Opioid Summit

- We are finalizing the agenda for the October 25 Opioid Summit [see attached flyer].
- Caleb Banta-Green from the University of Washington will be giving the keynote address providing the latest research on the use of Medication Assisted Treatment.
- There will be 3 panel presentations on the topics of Medication Assisted Treatment, Working with Jails and Drug Courts, and Prevention.

- There will also be a "Gallery Work" where many of the organizations currently working on addressing the Opioid Crisis can present the work they are doing. Conference participants will have on hour to walk around and learn about all of these different activities.
- The Summit will end with county specific and tribal break out groups to summarize what has been learned and how participants can work together on advancing some of the efforts that are in place.

 - Regions who wish to become a "mid-adopter" of fully integrated managed care (FIMC) must send a binding letter of intent to the Health Care Authority (HCA) indicating they're willing to implement integrated care in January 2019 rather than January 2020.

If Regions also choose to become a Behavioral Health Administrative Services Organization (BH-ASO), they must also send a letter of intent to the HCA. Counties have the "right of first refusal" regarding the choice to become a BH-ASO.

The North Sound was given an extension of the deadline to submit a letter of intent to become a midadopter of FIMC to October 6. A letter of intent to become a BH-ASO is due by mid-October.

A number of concerns have been raised by county councils/commissions regarding both choices. King County has submitted a letter of intent to become both a mid-adopter and a BH-ASO but has negotiated MOUs with the HCA and the five Apple Health Managed Care Organizations (MCOs) to establish a "Leadership Group" to "oversee" and "ensure" a successful transition to FIMC.

The MOU also articulates King County's assumption that the County would establish sub-contractual relationships with each successful MCO and the regional BHO to maintain the stability of the current system during the 2019 Transition period. "The MOU further assumes that there be adequate capitation funding and that each MCO will subcontract to the County certain Medicaid behavioral health services."

October 5, 2017

On a September 22 phone call from HCA Medicaid Director, MaryAnne Lindeblad, to Joe Valentine, MaryAnne indicated that the North Sound could send a single letter regarding both becoming a midadopter and a BH-ASO. We may also incorporate into the letter the conditions the North Sound feels need to be addressed. MaryAnne agreed to provide a written response to the requested conditions.

Motion #17-79

- Send a letter of intent on behalf of all the North Sound Counties to the Health Care Authority to become a "Mid-Adopter" of Fully Integrated Managed Care in January 2019, and to become the Behavioral Health Administrative Organization [BH-ASO] for the North Sound region.
- This letter should also indicate that the North Sound Region chooses to use the "2019 Transition Year" option in which the MCOs subcontract an agreed upon set of services and/or functions to the BHO for one year, and in which the BHO maintains non-Medicaid BH contracts for one year.
- This letter should include the following conditions:
 - Agreement from the Governor's Office and the Health Care Authority to fully support adoption of a statute establishing a permanent regional "Interlocal Leadership Structures" to be chaired by county authorities. This statute language will be modeled on the "BHO Proviso Language" that was introduced in the 2017 Legislative Session.
 - 2. Agreement from the Governor's Office and the Health Care Authority to seek a legislative budget appropriation providing sufficient dedicated funding to the North Sound Region to operate the BH-ASO. This funding should be sufficient to maintain the current continuum of care in the North Sound BHO administered Crisis Services and Diversion programs. This funding agreement will also allow the North Sound to submit a spending plan that will allow it to maintain a portion of their existing reserves and unspent funds to cover the estimated start-up costs of transitioning to a BH-ASO.
 - 3. Agreement from the Health Care Authority to allow the MCOs selected to serve the North Sound Region to contract with the BH-ASO for certain Medicaid Behavioral Health Services based on the proposed plan for fully integrated managed care developed by the North Sound Interlocal Leadership Structure. This plan should assure that clients are at the center of care delivery and should support integrated delivery of physical and behavioral health care at the provider level. This plan should also minimize duplication in administrative functions and support coordination of care as described in the "BHO Proviso Language".
 - 4. Agreement from the Health Care Authority to allow Counties through the Interlocal Leadership Structure to provide specific input into the North Sound "Addendum" to the 2018 RFP that will be used to procure the MCOs that will be providing Fully Integrated Managed Care in the North Sound. This should include the ability to recommend specific criteria to ensure that all persons in

the North Sound region have equal access to Medicaid health and behavioral health services, including those persons living in geographically challenged areas.

- 5. Agreement from the Health Care Authority to allow representatives of the county authorities to sit on the selection panel choosing the MCO's to be awarded the contract for the North Sound Region.
- 6. A stipulation that the North Sound region may withdraw its agreement to become a mid-adopter and/or a BH-ASO with 60 days written notice during the 2018 Legislative Session if the majority of the Counties conclude that these conditions are not being satisfactorily addressed.

Motion #17-80

 Send a letter of intent on behalf of the all North Sound Counties to the Health Care Authority to become a BH-ASO for the North Sound Regional Service Area only, in 2020. This letter would include the same conditions as #1-5 above.

Brief Eulogy for Greg Wennerberg

8 October 2017 Sukkot, Day IV

Today is the fourth day of the week-long Jewish holiday that we call "Sukkot," a harvest celebration that's a lot like American Thanksgiving. In fact, the Puritans who were so thankful for their harvest were fully aware of the Jewish tradition of Sukkot, which inspired them to celebrate their thanks.

One of the symbols of Sukkot is what we call, in Hebrew, a "Lulav." The Lulav is a hand-held "bouquet" of four small branches with their leaves or fruit. Each branch is from one of 4 types of tree representing one of four different types of person we might find in our communities. The types are based on two "righteous" behaviors — "learning" and "good deeds" — both of which are highly valued in the Jewish tradition.

Those four types of people are:

- People who value learning but ignore good deeds;
- People who do good deeds (who are kind), but have little or no learning (knowledge/ education);
- People who have neither learning/knowledge/education, nor are they kind (no good deeds); and
- People who value BOTH learning/knowledge/education AND good deeds (kindness toward others).

That last type of person — someone who values education and learning, values the common good, and treats people kindly — is a perfect description of Greg.

Greg was aware of the importance of social justice. He was kind. He did his homework — asking keen questions, researching, listening, and continually exploring healthcare issues so that he could contribute in the most effective way possible.

But, "learning" wasn't enough for Greg. He gave of himself to so many of us, and just one of his good deeds was volunteering on multiple boards and committees in Snohomish County and in the larger 5-county "North Sound" region. One of the boards on which Greg ably served for many years is the North Sound Behavioral Health Organization (the BHO) Advisory Board, of which I'm the Chair.

Greg was always well-informed (he did his "homework") and he would also frequently suggest creative and compassionate solutions to the challenges we often faced in serving people in our community who live with brain disorders and substance use disorders. And Greg was so often kind and attentive to others, even when he didn't feel well himself. He was an informed man. A thoughtful man. A kind man. A man who valued both learning and good deeds. And he was a friend to me.

Greg lived as the best part of the Lulav, and the best symbol of Sukkot. And I'm so very thankful that Greg was in our lives, that Greg contributed so much to improving healthcare in our region, and that I was able to call Greg a friend. I will miss him. A lot. We all will.
