Monitoring Methods for Integrated Managed Care

Alice Lind Health Care Authority



New System: Whole-Person Care

- For Apple Health clients, physical health, mental health and substance use disorder services will be managed by one managed care plan that is responsible for keeping them well both mind and body.
- A single MCO will coordinate care for their clients, across the full continuum of physical and behavioral health services.
- Access to Care standards no longer apply; care is provided based on level of care guidelines and medical necessity.
- MCOs are held to HCA network adequacy standards and must have an adequate network including essential behavioral health provider types.
- Medical and behavioral health providers will be contracted with the same payers (MCOs) and can move towards integrated clinical models that are supported by value-based and innovative payment methodologies.



Methods for Monitoring the IMC Model

Through the development of the IMC model within each region, and on an ongoing basis, HCA has a number of avenues to ensure a smooth transition and ongoing system improvement:

- Interlocal Leadership Structures
- Early Warning System Processes
- MCO and BH-ASO Contract Monitoring
- Maintaining Channels for Community Voice
- Monitoring Outcomes



Interlocal Leadership Structure

- House Bill 1388 passed in 2018, and included language regarding Interlocal Leadership Structures.
- Section 4062 states:
- (1) The authority shall, upon the request of a county authority or authorities within a regional service area, collaborate with counties to create an interlocal leadership structure... The interlocal leadership structure must include representation from physical and behavioral health care providers, tribes, and other entities serving the regional service area as necessary.
- (2) The interlocal leadership structure... must be chaired by the counties and jointly administered by the authority, managed health care systems, and counties. It must design and implement the fully integrated managed care model for that regional service area to assure clients are at the center of care delivery and support integrated delivery of physical and behavioral health care at the provider level.



Early Warning System Processes

- The Early Warning System (EWS) processes use both data and regular communication to track the transition to integrated managed care (IMC) regionally, enabling rapid feedback and identification of potential transition-related issues.
- Regional EWS Workgroups are responsible for overseeing the EWS at the local level.
- Specific tasks of a regional EWS Workgroup include, but are not limited to:
 - Reviewing standard indicators that HCA will collect and report on for each region.
 - Discuss additional indicators to include in the EWS, to be collected, analyzed, and reported at the local level.
 - Collecting baseline data for any selected "non-standard" indicators.
 - Participating in IMC check-in calls beginning after "go-live"
 - Participating in monthly webinars to review/discuss the EWS data.



HCA Contract Monitoring of MCOs

- Routine Reports from MCOs, e.g.
 - Initial Health Screen
 - Grievance and Appeal, Critical Incidents
 - Network submission, BH Network analysis
- Routine Reports from BH-ASO, e.g.
 - Expenditures
 - Crisis call response time
- Annual Monitoring:
 - Onsite monitoring visit with corrective action as needed



Channels for Community Voice

- HCA values the knowledge of consumers and communities to inform system change, as they hold critical information about the strengths and needs of the system.
- Examples of ways in which HCA obtains this information include:
 - Regional Behavioral Health Advisory Boards
 - Regional Ombuds
 - Family Youth System Partner Roundtables (FYSPRT)
 - Accountable Communities of Health (ACH)
 - Participation in local collaborative efforts and workgroups
 - Annual satisfaction surveys



Ongoing Monitoring of Outcomes

- HEDIS measures (e.g.):
 - Use of services including ambulatory care, inpatient utilization, mental health utilization
 - Quality of care; health outcomes
- Research and Data Analysis (RDA) Measures (e.g.):
 Integrated managed care preliminary findings
 - Psychiatric hospitalization readmission rate
 - Substance use disorder treatment engagement and penetration
 - Mental health treatment penetration
- Value-Based Purchasing including BH measures

Dedicated Marijuana Account (DMA)

Summary:

These Contract Amendments extend the contract through June 30, 2019 and provide funding for six months, January 1, 2019 through June 30, 2019. The DMA funds are used for youth drug prevention, intervention and brief SUD treatment in schools. BHO Medicaid funds are added to the contracts which requires a 9% match of local funds by the respective counties.

Motion

- North Sound BHO-Island County-PSC-18-19 Amendment 1 to increase funding by \$35,489 DMA funds and \$41,483 Medicaid funds for a new maximum consideration of \$76,972 with a new term of July 1, 2018 through June 30, 2019.
- North Sound BHO-San Juan County-PSC-18-19 Amendment 1 to increase funding by \$35,489 in DMA funds and \$32,588 in Medicaid funds for a new maximum consideration of \$68,077 with a new term of July 1, 2018 through June 30, 2019.
- North Sound BHO-Skagit County-PSC-18-19 Amendment 1 to increase funding by \$ for a new maximum consideration of \$ with a new term of July 1, 2018 through June 30, 2019.
- North Sound BHO-Snohomish County-PSC-18-19 Amendment 1 to increase funding by \$153,375 in DMA funds and \$9,898 in Medicaid Funds for a new maximum consideration of \$152,357 with a new term of July 1, 2018 through June 30, 2019.
- North Sound BHO-Whatcom County-PSC-18-19 Amendment 1 to increase funding by \$ for a new maximum consideration of \$ with a new term of July 1, 2018 through June 30, 2019.

Health Care Authority (HCA)

Transitional Housing

Summary:

- Lake Whatcom Center has doubled its transition bed capacity for individuals discharging from Western State Hospital.
- Compass Health will continue providing transitional bed capacity in Snohomish County for individuals discharging from Western State Hospital.

Motion

- North Sound BHO-LWC-Housing PSC-19 to continue transitional housing services in Whatcom County. The maximum consideration on this contract is \$36,000 with a term of January 1, 2019 through June 30, 2019.
- North Sound BHO-Compass Health-Housing PSC-19 to continue transitional housing services in Snohomish County. The maximum consideration on this contract is \$15,000 with a term of January 1, 2019 through June 30, 2019.

Whatcom County Health Department

Summary:

Whatcom County has requested Medicaid funding to furnish the Whatcom County Crisis
 Stabilization facility. The funding will purchase furniture for one of the two units at the facility.
 The county will be matching the Medicaid funds with 31% local funds.

Motion

■ North Sound BHO-Whatcom County-PSC-19 to purchase furniture for the Whatcom Crisis Stabilization Facility. The maximum consideration on this contract is \$138,000 with a term of January 1, 2019 through June 30, 2019.

NORTH SOUND BEHAVIORAL HEALTH ADVISORY BOARD

2019 LEGISLATIVE PRIORITIES

1. Maintain Current Level of Funding for the Behavioral Health Crisis System

- With the transition to Integrated Managed Care, Medicaid funding and State General Funding [GF-S] for Crisis Services will come from two different sources: Medicaid funding from the Apple Health Managed Care Organization [MCOs] and GF-S from the Health Care Authority [HCA] based on legislative appropriation.
- New Behavioral Health Administrative Services Organizations [BH-ASOs] will replace the existing regional Behavioral Health Organizations and will be responsible for overseeing and funding Crisis Services.
- Ensure there is sufficient funding to both Mmaintaining the existing continuum of crisis services as well as nd expanding opportunities for diverting people from jails and hospitals will be critical. However, under the new model, there is no guarantee that the existing levels of Medicaid funding will still be available to the BH ASOs.
- Please ensure that enough GF-S is allocated to maintain the stability of the existing crisis system and to make sure that the ability to expand diversion opportunities for diversion from jails and hospitals and that this funding is not solely dependent on the business decisions of the MCOs.

2. Enforce Accountability Standards for the Managed Care Organizations

- Please ensure that state agencies hold the MCOs accountable to meet the performance standards for the funding they are receiving to provide integrated managed care.
- Please ask the state agencies to work with local communities, including the regional Behavioral Health Advisory Boards, in monitoring the performance of the MCOs.
- Please support legislation to maintain the ability of counties to have oversight of Crisis and Non-Medicaid services as well as regional county chaired Interlocal Leadership Structures

3. Support the North Sound Counties' Request for the Additional Capital Funding to Complete the Projects Partially Funded in the 2018 Capital Budget.

- In 2017, the North Sound counties submitted a capital funding request to address the significant shortage of behavioral health treatment beds in the North Sound region.
- The 2018 Capital Budget provide partial funding to begin these projects. These included: Two Substance Use Disorder [SUD] Treatment Facilities in Everett, a new Mental Health Crisis Center and a new SUD Detox Center in Bellingham, a new Evaluation & Treatment Facility and a new SUD Detox Facility in Skagit County to replace the E&T and SUD treatment facilities in Sedro Woolley that will lose their leases, and a new Crisis Center in Island County.
- The necessary land sites have been procured and building designs have been completed for all these projects. *An additional* \$221.59 million is needed to bring them to completion.

North Sound Behavioral Health Organization

2019 Behavioral Health Facilities Capital Funding Request

- In 2017, the North Sound Region Counties submitted a capital funding request to address the significant shortage of behavioral health treatment beds in the North Sound Region.
- The 2018 State Capital Budget provided enough funding to begin development of most of the projects prioritized for the 2017 2019 biennium.
- Development of all the facilities that received funding are now underway: there are secured sites for each facility and the initial schematic designs, detailed cost estimates, and environmental assessments completed.
- Three of the funded projects will need additional funding to complete construction.
- The Skagit Stabilization Campus projects received only partial funding in 2018 contingent on the procurement of land to locate the facilities. A parcel of land has now been purchased by Skagit County for these projects.
- An additional 8 bed wing of SUD treatment and detox beds is proposed for the Skagit Stabilization Campus to be designed and partially funded in partnership with North Sound Tribes.
- The SUD Residential Treatment Centers that will occupy the re-purposed Denny Juvenile Justice Center will need an additional \$5.1 million but Snohomish County will be covering \$2.1 million with local millage dollars. The request for 2019 Capital Dollars would be for the remaining \$3 million.
- Even with the opening of the new facilities, the North Sound region will still have an insufficient number of SUD residential treatment beds to meet current needs, and this need will grow over the next 5 years with the continued growth in population.
- Attached is an updated bed need projection based on the projections that two different planning consultants did in 2016 and 2017. Population growth has continued at a steady pace to support these projections. [see attached bed need projection].
