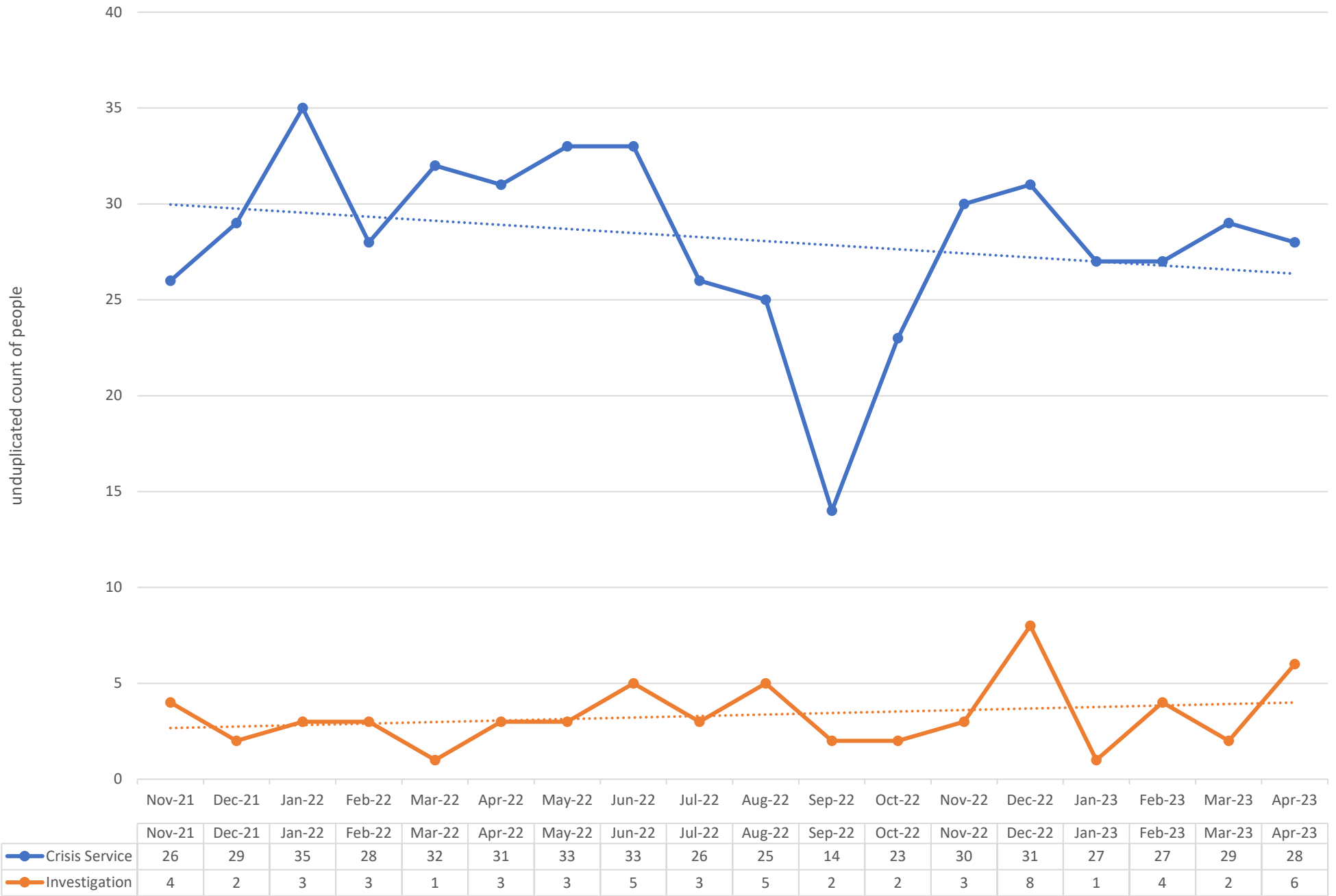

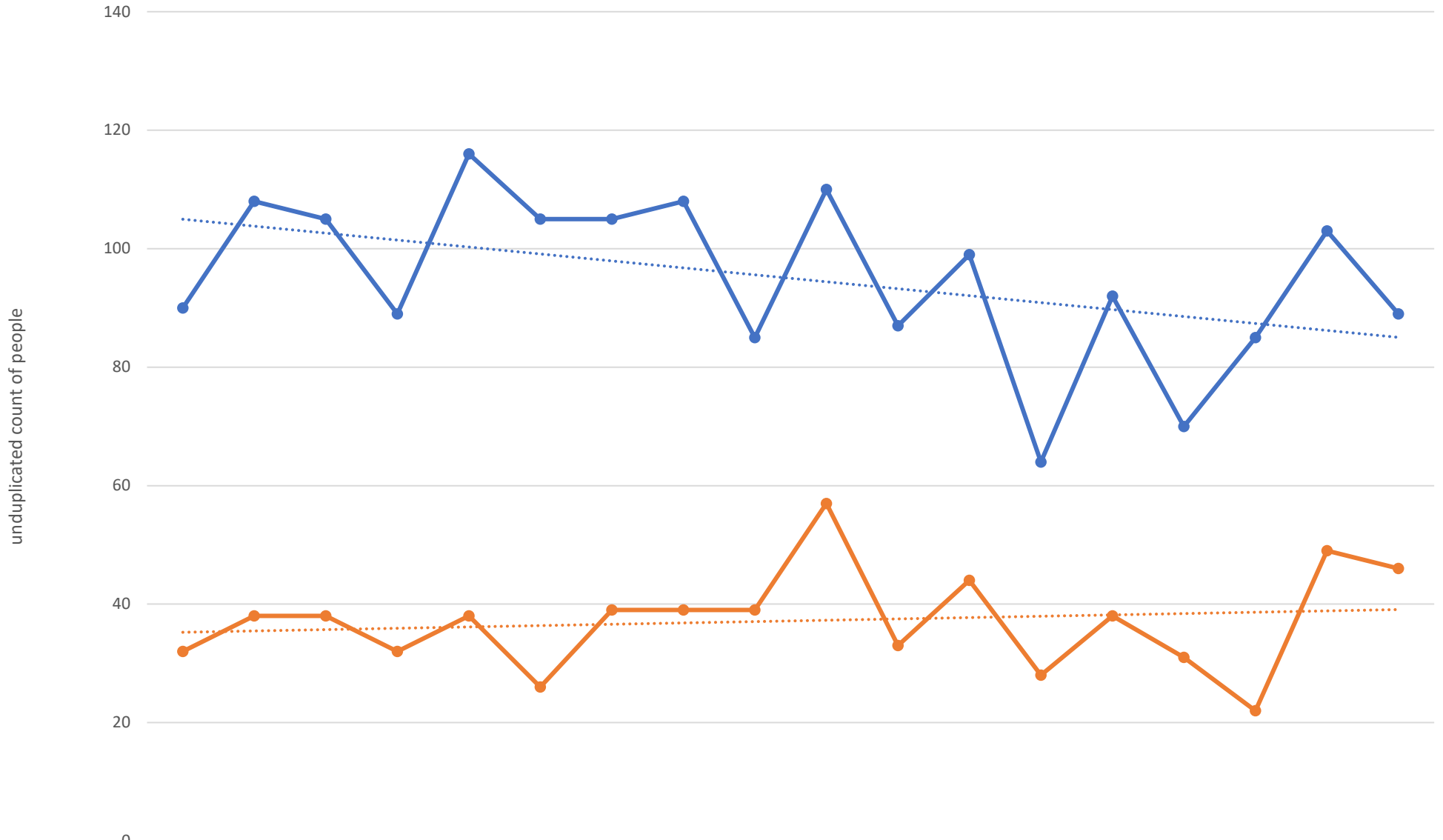

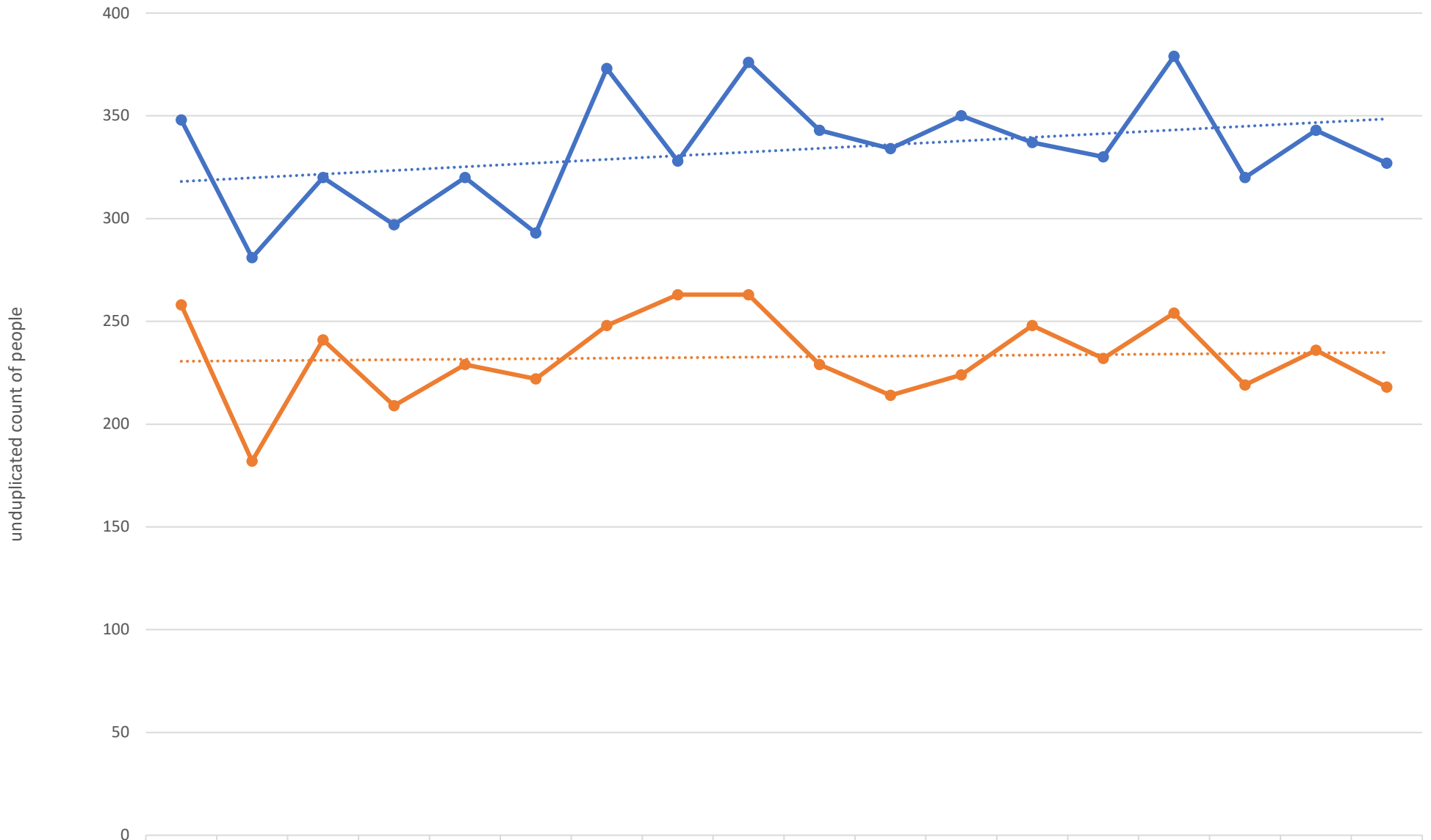


Skagit - Unduplicated People receiving a crisis system service



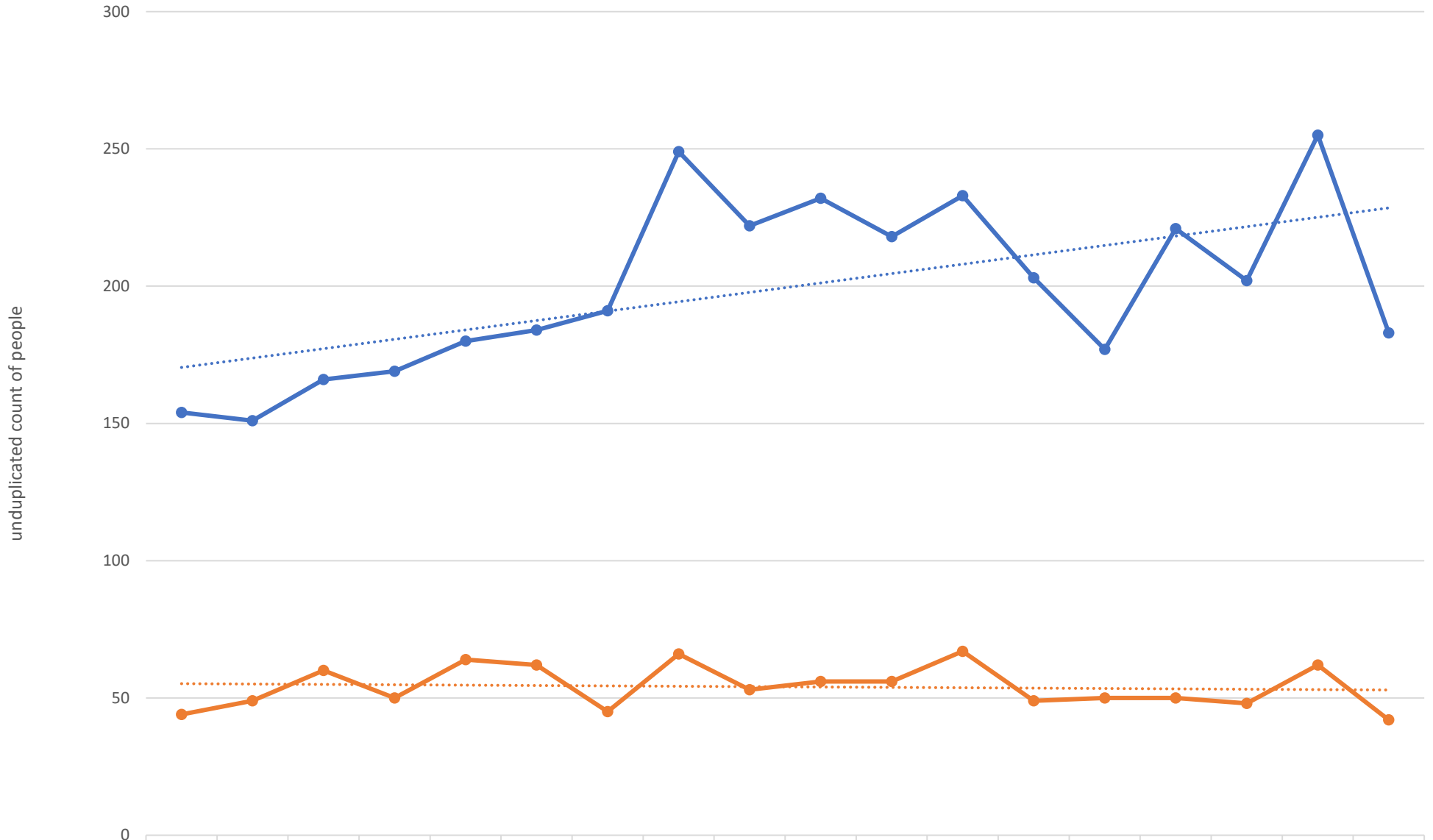

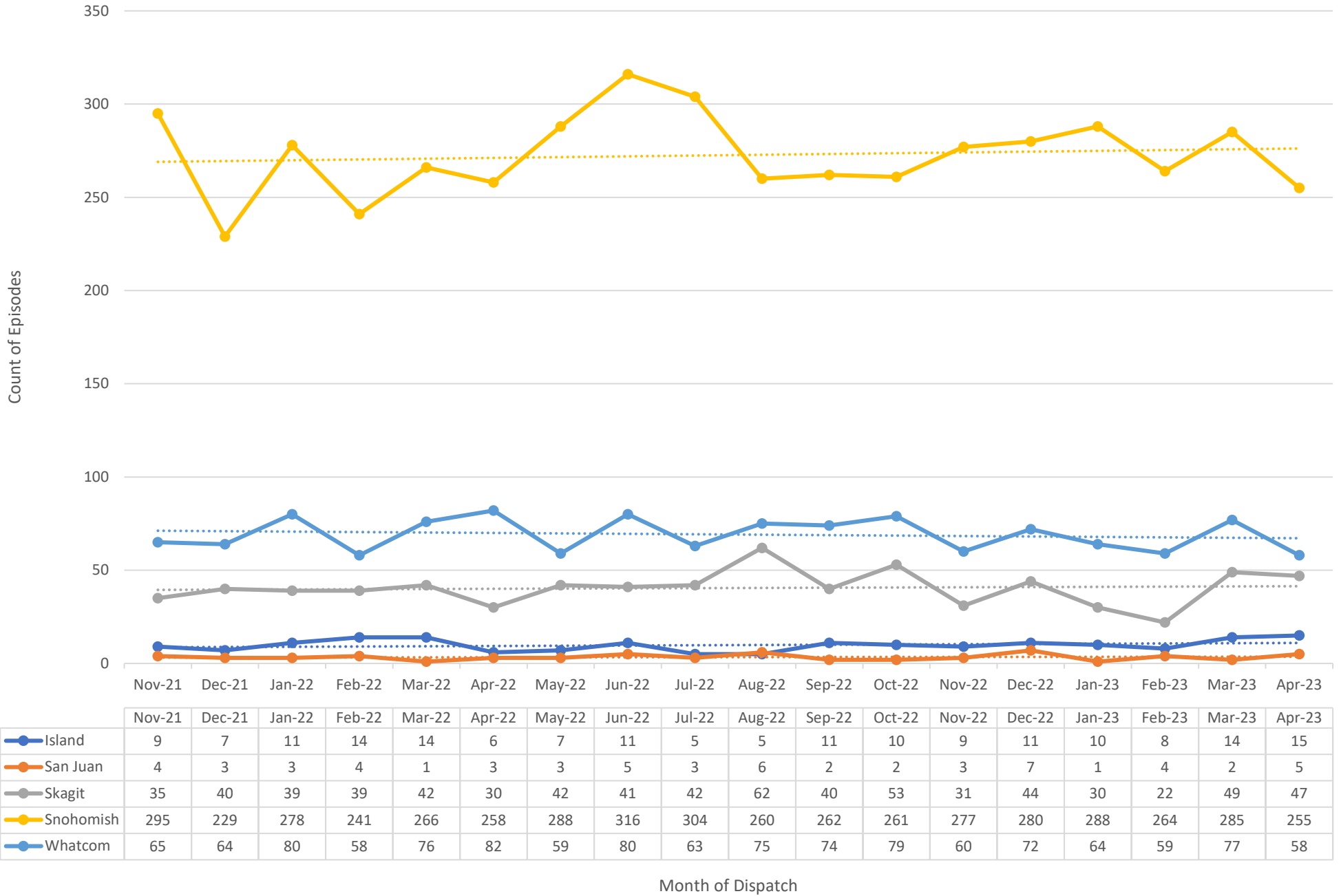

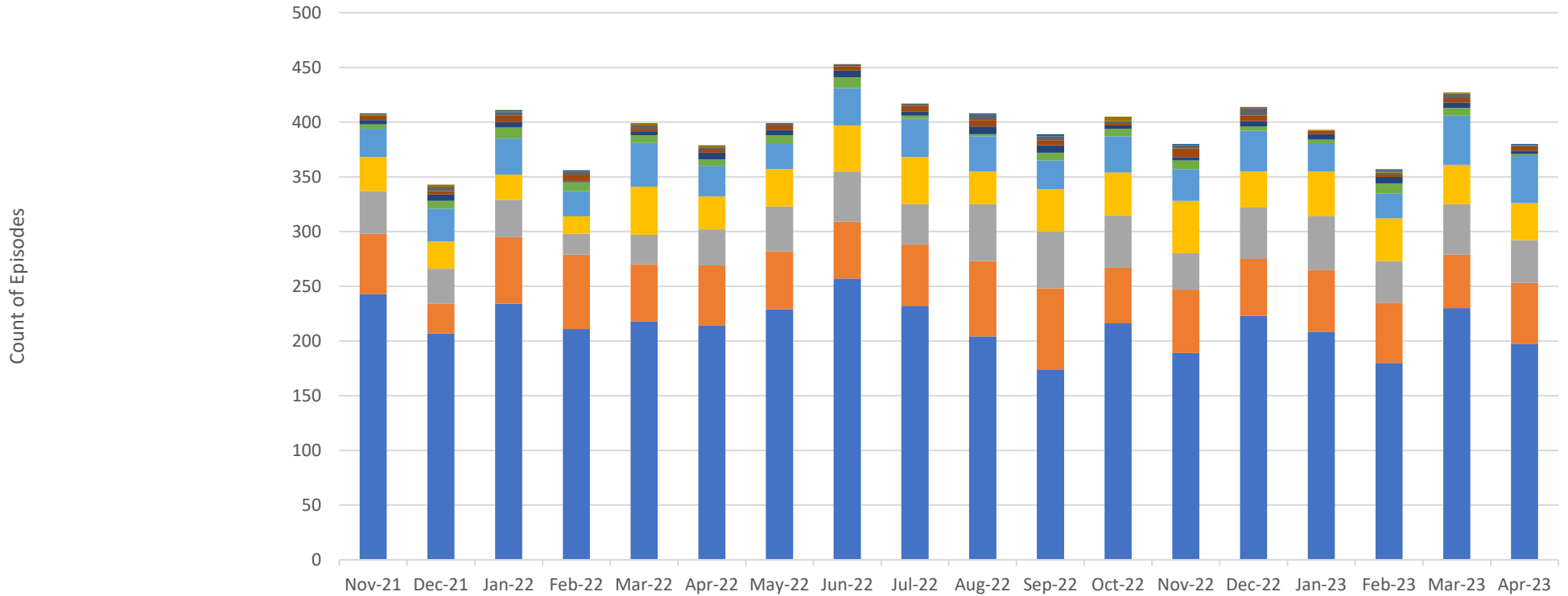

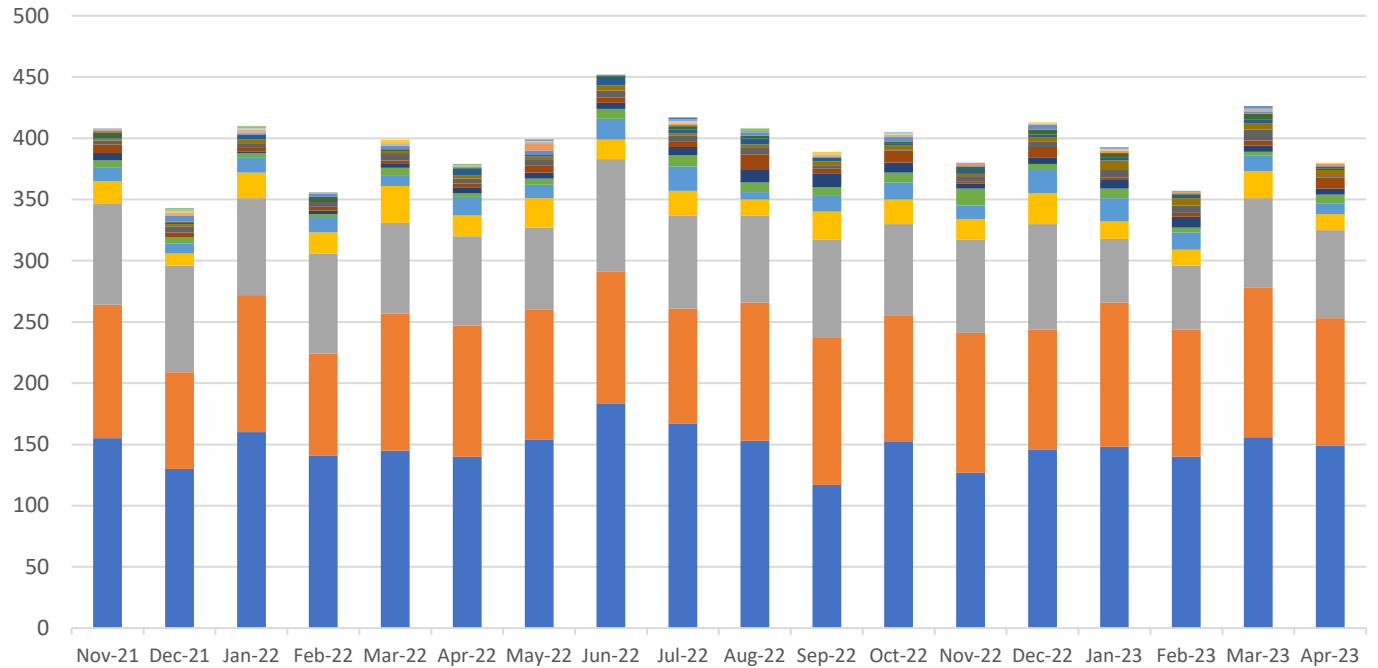
