# For Executive Committee Approval

- Compass Health is expanding its current WISe teams in Island and Snohomish Counties. Island County is receiving 9 additional slots for a total of 27 and Snohomish is receiving 8 additional slots for a total of 130.
- Center for Human Services (CHS) is receiving 10 slots for a new team in South Snohomish County, CHS provides WISe services in King County.

## Motion #17-69

# Behavioral Health State Contract (BHSC) and Medicaid

• Compass Health is developing an Outreach Team in San Juan County. This team will be available in the community and at local resource centers on San Juan, Lopez and Orcas Islands. The team will conduct outreach, engagement and crisis prevention/intervention. State funding is being reduced slightly and Medicaid funding increased, for an overall increase of \$190,998.

#### Motion #17-70

# **Skagit County Prosecuting Attorney**

• Skagit County PA Office has provided the requested information to formulate their new case rate for ITA services. This rate is a reduction of \$36 from the 2016 rate of \$950.

## Motion #17-73

Approve the new ITA case rate, effective January 1, 2017, the ITA rate reimbursement for Skagit County is \$914 per case.

### Skagit County Prosecuting Attorney

• The PA's office is asking the BHO to cover the costs of temporary staffing costs due to an Assistant PA out on maternity leave. North Sound reimburses the counties on a case rate basis, not on an hourly rate for ITA court services. This ask is in addition to the case rate we pay for ITA court services.

## Motion #17-74

Approve payment in the amount of \$4,859.44 for the temporary staffing costs to cover leave for the ITA court services personnel. Motion #17-74 was discussed. Geoffrey Thomas moved the motion to be tabled until the next meeting in October, Darcy Cheesman seconded, all in favor, motion approved to be tabled until the October meeting. Brad Furlong, North Sound BHO Counsel, spoke and noted he felt more comfortable having conversation in the Executive Session for confidentiality purposes. This topic will be added to the October Meeting's Agenda.

#### Mid Adopter

• The State has offered financial incentives to Regions who choose to move to an integrated care model in January 2019, rather than 2020 – the "mid-adopter" option. Those regions in which the County Authorities choose the mid-adopter option must submit a "binding letter of intent" to the Health Care Authority [HCA] by September 15. HCA has agreed to extend the deadline for the North Sound's letter to September 22. All counties in a multi-county region must agree. This motion would approve sending a recommendation from the BHO County Authorities Executive Committee to each of the five County Councils/Commissions that the County Authorities agree to the midadopter option.

On September 5, the North Sound BHO Advisory Committee voted to recommend to the North Sound County Authorities Executive Committee that they recommend approval of the mid-adopter option.

#### Motion #17-75

Recommend to the North Sound County Councils and Commissions that they approve the North Sound BHO County Authorities Executive Committee sending a "binding Letter of Intent" to the Washington State Health Care Authority [HCA] indicating that the North Sound Region wishes to become a "mid-adopter" of Fully Integrated Managed Care in January 2019.

The Chair asked the counties if they would like to discuss the pros and cons of being a mid-adopter. Dialogue followed as the counties deliberated on their thoughts pertaining to the knowns and unknowns provided by Health Care Authority's answers to their questions.

Ken Mann moved the motion for approval.

Regina Delahunt made a motion to amend the current motion on the table which will reflect the conditions below:

- 1) Condition to allow Managed Care Organizations (MCO)s to contract back with the Behavioral Health Administrative Services Organization (BH-ASO) for some of the services and functions the Behavioral Health Organization (BHO) now provides
- 2) Adequate ASO with dedicated funding, including the option of allowing the BHO to use unspent money to support the operation of the BH-ASO
- 3) Formalization of the Inter-Local Leadership Structure in statute

Cammy Hart-Anderson seconded the motion.

The motion continued, noting there would be 3 conditions, as expressed, to become a mid-adopter with the transition year, 7 approved, 2 disapproved, motion carried.

Joe noted the North Sound BHO will attempt to find a date the first week in October in case the additional special session is needed. He also offered to draft language describing the above conditions for consideration by the County Councils and Commissions.

- PathFinder funding is a Substance Abuse Mental Health Services Administration (SAMHSA) Grant for the specific purpose of a State Targeted Response to the Opioid Crisis (STR-CFDA 98.788). The payment methodology on this contract is performance based.
- The DBHR PathFinder Grant is a new stream of funding to add capacity to our current PATH contracts. This funding
  is specifically for adding Substance Use Disorder Peers to the teams, two Peers in Snohomish County and two Peers
  in Whatcom County.
- Compass Health is the PATH provider in Snohomish and Whatcom County, the PathFinder funds are being allocated to the PATH teams in Snohomish and Whatcom Counties.

#### Motion #17-76
